19 On the above captioned date and time, the court considered its Order to Show Cause Why  
20 Sanctions Should Not Be Imposed Against Randy Alexander, State Bar No. 183881, For Failing  
21 To Comply With General Order 06-03 and Local Bankruptcy Rule 5005-4 ("OSC") dated  
22 December 12, 2012. Appearances were stated on the record. Based upon findings of fact and  
23 conclusions of law stated on the record pursuant to F.R.Civ.P. 52(a)(1), as incorporated into  
24 FRBP 7052 and applied to contested matters by FRBP 9014(c), it is

25 ORDERED that Randy Alexander, State Bar No. 183881 ("Alexander") is sanctioned the  
26 sum of \$750.00 for violation of LBR 5005-4; and it is further

27 ORDERED that payment of the sanction imposed by this order must be made to the clerk  
28 of court within 21 days from the entry of this order; and it is further

1 ORDERED that failure to timely pay the sanction imposed by this order will result in an  
2 automatic suspension from practice before the United States Bankruptcy Court for the Central  
3 District of California; and it is further

4 ORDERED that to terminate a suspension imposed pursuant to this order, Alexander  
5 must file an ex parte application for reinstatement, supported by a declaration and any other  
6 evidence establishing payment of the sanction amount and cause for reinstatement. A proposed  
7 order granting reinstatement must be lodged with the court upon the filing of the application for  
8 reinstatement.
