

### **Project Overview:**

The project has been awarded to South State, Inc. in the amount of \$586,788.16. The estimated construction duration is **Forty (40) Working Days** for Substantial Completion and **Sixty (60) Working Days** for Final Completion. The Notice to Proceed was issued with a start date of **Monday, October 22, 2018** and a completion date for ALL WORK of **Friday, January 18, 2019**.

The project involves the replacement of deteriorated sections of the concrete roadway with prefabricated reinforced concrete slabs. The project will be constructed in two phases utilizing lane shifts to maintain one lane of travel in each direction. Parking will be restricted throughout the project limits to accommodate the lane shifts. Overall, 65 concrete slabs are schedule to be replaced with 50 scheduled during Phase 1 and 15 in Phase 2. Handicap ramps will be upgraded at the 20<sup>th</sup> Street intersection. After installation of the concrete slabs, the entire roadway within the project limits will be diamond ground to create a smooth riding surface and the existing striping patterns will be reinstituted.









#### **Work Completed this Report Cycle:**

- Phase 1 Traffic Control Devices remain in place and lanes remain shifted to the north.
   Phase 1 Work Zone continues in southernmost lanes of Federal Street. Camden County Police Department providing Police Traffic Directors.
- Removal of existing slabs, preparation of subbase, installation of dowels and setting of new reinforced precast concrete slabs continue on a daily basis.
- The handicap ramps at the 20<sup>th</sup> Street intersection were installed to ADA standards. Concrete was protected from forecasted snow storm.
- All 50 of the Phase 1 slabs (100%) have been set to date. Grouting of the dowel pockets will be performed for the Phase 1 slabs prior to the Phase 2 lane shift.

#### **Changes to the Initial Contract items:**

- A Field Revision was issued by the Design Engineer, KMA Consulting Engineers, Inc. on November 6, 2018 whereby two existing "A" inlets previously slated to be converted to manholes are to remain in place and will be reset to grade under the pay item "Reset Existing Casting".
- The prefabricated manhole opening in Slab K38 did not align with the existing manhole. A Field Directive was issued by the County Engineer on November 7, 2018 to remediate the unforeseen condition. A sawcut is to be installed 2' to the west of the previously set Slab K3. Slabs K3 through K9 to be removed and reset 2' to the west. Slabs K35 through K38 to be set 2' to the west in order to align with the manhole. The 2' opening at the western edge of the slabs to be infilled with pour in place concrete per NJDOT Standard Construction Detail for slab repairs. Supplemental Item "Precast Slab Adjustment at K38" to be added to the contract after freeholder approval of Change Order in the amount of \$15,204.31.

### **Work Completed this Report Cycle:**

- All 50 of the Phase 1 slabs (100%) have been set to date. Pressure grouting of the dowel pockets, joints and underslab completed this report cycle. Slab openings and repair areas infilled with 4,000 psi concrete.
- All Phase 1 work completed with the exception of installing a "B" inlet eco-friendly curb piece.
- Phase 2 Traffic Control Devices installed and lanes shifted to the south. Phase 2 Work
  Zone in northernmost lanes of Federal Street. Camden County Police Department
  providing Police Traffic Directors.
- Phase 2 sawcutting and demolition of slabs slated for replacement has commenced.
   Materials and equipment required for installation of Phase 2 slabs have encroached onto the westbound lanes resulting in a police mandated lane closure and detour. Westbound traffic is redirected up East State Street to River Road then back to Federal Street.
- Eleven of the fifteen Phase 2 slabs have been installed to date. New Jersey American Water (NJAW) was notified of a sinkhole near a watermain and slab installation near the sinkhole was delayed until a NJAW subcontractor could repair the cause of the sinkhole. Repair of the watermain and sinkhole was completed on Friday, November 30, 2018.
