Work Completed the Week of July 5, 2021:

Asphalt Paving Systems subcontractor, Clean Earth Matters, cut perimeters of inlets for Phase 1 of reconstruction, excavation, and construction of inlets from Station 11+00 to 53+00 (Almonesson Road). Clean Earth also located gas lines behind the inlets at Stations 20+50, 24+50, 28+00 and at the two corners on Beech Drive where ADA compliant ramps will be poured, all along the Southbound Lane. APS arrived on site later in the week and began excavation of sidewalks and curbs on Beech Drive and set up forms and compact subbase for ADA compliant curbs. APS also excavated, compacted subbase, and set up forms starting 10 feet from proposed Double B Inlet construction at Station 28+00 (Apple Ave) down to station 25+00 (Poplar Ave) in preparation to pour concrete Monday morning. Beech Drive was closed during working hours, and a double lane shift was implemented with an officer to ensure the safety of the workers.

Road Improvement Project Good Intent – Lower Landing Road (CR 681) Township of Gloucester, Camden County, New Jersey 7/12/21 to 7/16/21 - Weekly Progress Report #4

Work Completed the Week of July 12, 2021:

Asphalt Paving Systems subcontractor, Clean Earth Matters, began construction on a Double B inlet (complete) at Station 28+00 across from Apple Ave on Lower Landing Road along Southbound Lane. Clean Earth Matters completed construction on Inlet Type B (complete) next to existing Inlet Type B, reconstructing Inlet Type B at Station 24+50 across from Poplar Ave. Type Double B inlets and inlets with a new Type B inlet (complete) next to an existing Type B (reconstruct) are being constructed using a 4-foot steel beam to set the two heads in the middle of the inlet walls. Clean Earth also reconstructed inlet at Station 16+50 and began reconstruction on inlet 13+50.

APS poured ADA compliant concrete sidewalks at the corners of Beech Drive with Detectable Warning Surfaces. APS poured 650.50 LF of curb stretching from Station 27+84 to 21+39 and at corners of Beech Drive where ADA compliant sidewalks were poured. After pouring 9" x 16" concrete vertical curb, APS continued to excavate and set up forms along the Southbound Lane of Lower Landing Road. APS along backfilled and compacted where curb was poured along the Southbound Lane. Beech Drive was closed during working hours on Monday July 12th to pour and finish ADA compliant ramps but only a lane shift was implemented with an officer present on the rest of the days.

Road Improvement Project Good Intent – Lower Landing Road (CR 681) Township of Gloucester, Camden County, New Jersey 7/19/21 to 7/23/21 - Weekly Progress Report #5

Work Completed the Week of July 19, 2021:

Asphalt Paving Systems subcontractor, Clean Earth Matters, reconstructed B inlets with new casting along Lower Landing Road at Stations 45+00 (Northbound Lane), 53+00 (Almonesson Road, Westbound Lane), 34+50 (Northbound Lane), 38+50 (Northbound Lane) and 11+00 (Southbound Lane). Inlets at Stations 20+50 (Southbound Lane) and 24+50 (Southbound Lane) were reconstructed as a sideby-side Type B inlets, so one inlet being a Type B Inlet complete and the other being a Type B Inlet reconstruction. All reconstructed inlets were parged and necessary blocks were replaced, and new castings were installed. All Double B inlets or inlets with two Type B inlets side by side were built with a 4-foot steel beam in the center of the inlet.

Asphalt Paving Systems poured gutters 10 feet on both sides of inlets all along the Southbound Lane of Lower Landing Road at Stations 16+50, 20+50, 24+50 and 28+00, totaling 85 linear feet. Excavation area around the gutters were infilled with asphalt so that traffic could drive over those areas once the road was opened back up. APS also poured a total of 799 linear feet of 9"x16" concrete vertical curb along the Southbound Lane of Lower Landing Road finishing the stretch between Beech Drive and the 42 ramp. On Wednesday, July 21st, the concrete truck load was rejected with a slump of 5½ between Stations 27+84 to 28+13 and the area is being monitored for cracking or spalling in the concrete curb. No roads were closed but a lane shift was implemented during working hours with a crash truck and a police officer present to ensure the safety of the workers.

Road Improvement Project Good Intent – Lower Landing Road (CR 681) Township of Gloucester, Camden County, New Jersey 7/26/21 to 7/30/21 - Weekly Progress Report #6

Work Completed the Week of July 26, 2021:

Asphalt Paving Systems dug test pits at the intersection of Almonesson Road and Lower Landing Road to verify locations of gas, water, sanitary and force main lines. After verification of existing utility elevations, it was determined that a gas line will have to be relocated due to obstruction with an existing storm sewer that is proposed to be replaced. A Police Officer was present and traffic control conditions were met to ensure the safety of the workers.

APS subcontractor, Clean Earth Matters, completed (2) Inlet, Type B (Complete) and (7) Reconstructed Inlet Type B, using New Casting along Lower Landing Road on the North Side of the Almonesson and Lower Landing Intersection. All reconstructed inlets were parged and necessary blocks were replaced, and new castings were installed.

Asphalt Paving Systems poured concrete gutters 10 feet on both sides of inlets along both the Southbound Lane and Northbound Lane of Lower Landing, totaling 50 linear feet. Excavation area around the gutters were restored with asphalt. APS also poured a total of 259 linear feet of 9"x16" concrete vertical curb along the Southbound Lane and Northbound Lane of Lower Landing Road. No roads were closed but a lane shift was implemented during working hours with a crash truck and police officers present to ensure the safety of the workers.

APS will continue along the Southbound Lane of Lower Landing Road on the Northside of Almonesson Road setting forms and pouring for curbs, aprons and gutters. APS's subcontractor, Clean Earth Matters, will continue to work on inlets. APS will also have a second crew present to start laying pipe on the other end of the project by the bridge on the county line. SJ Gas will also be onsite to relocate the existing gas main.

Work Completed the Week of August 2, 2021:

Asphalt Paving Systems pipe crew dug test pits between STA 78+00 – 83+00 to verify locations of bridge approach slab, gas and water lines. After determination of existing utility elevations and bridge approach slab, it was determined that the existing Type E inlets will not be replaced, and a Double B inlet will be deducted, adding a Single B inlet highlighted in RFI #3. Also, (2) Double B inlets will be moved approximately 50 feet towards the bridge from its original proposed location to STA 80+50. This week, (1) Type B inlet was installed at STA 81+55 (Southbound) and (1) Double B inlets was installed at STA 80+10 (Southbound). 138 linear feet of 18" Reinforced Concrete Pipe was installed between STA 80+50 and 82+00. (2) police officers were present with slow/stop paddles at Stations 76+00 and 83+00 to flow traffic in the one lane.

APS concrete crew poured concrete for sidewalks, aprons, curbs and gutters along Lower Landing Road. APS poured a total of 18.78 SY of 4" concrete sidewalk, 67.67 SY 6" concrete driveway, 1,013 linear feet of 9" x 16" Concrete Vertical Curb and 83 linear feet of gutters (10 feet on both sides of inlets). All aprons were reinforced with welded wire, all curbs, gutters, aprons and sidewalks were backfilled and compacted with DGA and restored with asphalt. All work this week was completed along the Northbound Lane of Lower Landing Road. No roads were closed but a lane shift was implemented during working hours to ensure the safety of the workers.

Clean Earth Matters was only on site Monday this week and reconstructed a B inlet with new casting at STA 41+50 along the Southbound lane and a E inlet with new casting at STA 38+50 also along the Southbound lane. All reconstructed inlets were parged and necessary blocks were replaced. They were not able to reconstruct anymore inlets on Phase 1 of Lower Landing Road because the lane shift would not allow workers to be operating safely on both sides of the road.

WEEKLY PROGRESS REPORT #8 August 9, 2021 to August 13, 2021

Work Completed the Week of August 9, 2021:

Asphalt Paving Systems pipe crew installed 111 LF of 18" Concrete Reinforced Pipe between STA 78+00 and 83+00 and 12" Ductile Iron Pipe was installed at STA 65+00. All pipe was installed with rubber gaskets at bell and spigot connections and fabric and mortared around the joints. All holes in the pipe were filled with pop-its and covered with mortar and fabric. Crossings in the road where pipe was installed were filled with flowable fill and asphalt was restored before opening area up to traffic. (2) Inlet Type B inlets were reconstructed at the crossing with 12" Ductile Iron Pipe on both sides of the road at STA 65+00. (2) Pre-Cast Double B inlets were installed at STA 80+00 on both sides of the road with 6" heads. (2) police officers were present at both STA 76+00 – 83+00 and STA 65+00 with slow/stop paddles to flow traffic in one lane.

APS concrete crew poured concrete for sidewalks, aprons, curbs and gutters along Lower Landing Road. APS poured a total of 0.58 SY of 4" concrete sidewalk, 98.255 SY of 6" concrete driveway aprons, 680 LF of 9" x 16" Concrete Vertical Curb and 60 LF of gutters (10 feet on both sides of inlets). All aprons were reinforced with welded wire, all curbs, gutters, aprons and sidewalks were backfilled and compacted with DGA and restored with asphalt. All work this week was completed along the Northbound Lane of Lower Landing Road. No roads were closed but a lane shift was implemented during working hours to ensure the safety of the workers.

Clean Earth Matters reconstructed (4) B inlet with new castings along both the Southbound and Northbound Lanes of Lower Landing Road. Clean Earth dropped back and completed missed inlets on Phase 1 of the project (North side of Almonesson/Lower Landing Intersection) due to traffic lane shifts last week and are beginning to move along to Phase 2 of the project (South side of Almonesson/Lower Landing Intersection). All reconstructed inlets were parged and necessary blocks were replaced.

APS FDR crew pulverized, mixed in Portland cement and compacted from STA 13+50 to 43+50 on both sides of the road. At the end of each day, they tacked the surface of the road with fog seal to prevent dust spreading from traffic driving over it.






Figure: 1 – Example of APS performing a base repair along Lower Landing/Good Intent Road (CR 681) prior to installing HMA9.5M64 surface course.




