Work Completed the Week of January 27, 2020:

A notice to proceed was issued to South State, Inc. to begin work on January 13, 2020. South State used the first two weeks to set up traffic control signage, install soil erosion measures and mobilize equipment and materials to the site. South State's pipe crew mobilized to the site on Monday, January 27th completed site clearing and test pits to confirm utility locations before installing storm sewer pipe. The pipe crew then installed 16 linear feet of 15" RCP, 7 linear feet of 18" RCP, 32 linear feet of 24" RCP, 12 linear feet of 30" RCP, 96 linear feet of 36" RCP, 5 cubic yards of 30" concrete headwall, 2 type B inlets and 1 4' diameter storm sewer manhole. The pipe crew also installed 49 square yards of rip rap, reconstructed 2 inlets, removed 1 tree and trimmed several other trees.




