Energy Conservation Assistance Program and Air Conditioner Offer Application



1. The following terms and conditions (the "Terms and Conditions") govern applicants' participation in the Energy Conservation Assistance Program ("ECAP"), under which eligible applicants may receive certain energy efficient and other products, including a portable air conditioner unit (an "AC Unit").
 2. Applicants who do not satisfy the eligibility requirements for the ECAP Program set out in section 5 may still be eligible to receive an AC Unit (the "AC Unit Only Offer") if they satisfy the eligibility requirements the AC Unit Only Offer set out in 2(f)-(h).
 3. The Program is administered and/or funded, in whole or in part, by FortisBC Energy Inc. and FortisBC Inc. (collectively, "FortisBC"), with funding for portable air conditioner units from the British Columbia Ministry of Health (the "Ministry").
 4. Residential property refers to the home occupied by an income-qualified owner or tenant at the address listed on this application and meets the qualifications set out below.
 5. **Eligibility requirements:**
 - a. Must be of a legal age of at least 18 years old as of the time of submission of this application;
 - b. Must be the current lawful occupant of the residential property and occupy the property as their primary residence;
 - c. Be the active FortisBC Inc., municipal utility of Summerland, Penticton, Grand Forks, or Nelson Hydro residential account holder for the eligible residence,
 - d. If a tenant, obtain consent from the owner in the form found at www.fortisbc.com/ecap (the "Landlord Consent") and submit the completed and signed Landlord Consent form and
 - e. Either:
 - i. Have a household income that does not exceed the applicable amounts specified at www.fortisbc.com/ecap and submit one of the accepted proof of income documents specified therein for each member of the household 18 years of age or older.
 - ii. A medical referral letter for clients of the regional home health programs Note: Applicants only seeking the AC Unit Offer are not required to be the FortisBC residential account holder for the eligible residence.
 6. **Eligible residences:**
 - a. Eligible residences for the ECAP program include single family detached homes, townhomes, rowhomes, duplexes, and manufactured/ mobile homes. Note: apartment and condominium units are not eligible residences for the purpose of the ECAP program but are eligible residences for the purposes of the AC Unit only offer.
 - b. Must not have an existing, functioning air conditioner unit to qualify for an AC Unit.
 7. The residential property must be a fully serviced existing building suitable for human habitation that is occupied on permanent year-round basis (attached garages, outbuildings, buildings under construction, and unoccupied buildings are not eligible), and deemed to be in suitable condition for the improvements available through the program.
 8. FortisBC reserves the right to, at any time, verify the accuracy and completeness of any and all information provided by the applicant, and the applicant must cooperate with this verification process. The applicant must notify ECAP Operations if any information provided as part of this application changes at any time after the submission of the application.
 9. FortisBC may without penalty or obligation, at its sole discretion, at any time, modify any terms or conditions or any of its requirements for program eligibility, and modify or terminate the program.
 10. FortisBC has the right to prioritize applications for program support within available funding based on any criteria deemed appropriate.
 11. The availability, timing, and amount of program support are subject to available program funding.
 12. FortisBC is not obligated to provide program support to any applicants including those who meet all program eligibility criteria. It is within FortisBC's sole discretion to accept or reject any applicant who meets all program eligibility criteria.
 13. ECAP Program households (determined by service address) are not eligible to receive the program more than once every 10 years.
 14. AC Unit Only Offer Applicants must not have received an AC unit as part of the program.
 15. FortisBC will decide in its sole discretion which improvements an approved applicant will receive.
 16. Services for applicants in remote or hard-to-service locations and the timing thereof may vary.
- Applicant declaration and consent**
- I confirm that I am the owner of the above household or, if not, that I have the owner's permission to proceed with this application and the implementation of improvements to the household as contemplated by the program.
 - If I am a tenant, I understand that any improvements completed under this program cannot form the basis for an increase in rent above the provincial guidelines as it is not an expenditure that my landlord will have incurred.
 - If this application is approved, I grant permission for the program contractors to:
 - Conduct a free evaluation of my home that includes suitability for an AC unit and/or ENERGY STAR® certified refrigerator to be installed and for energy efficiency considerations.
 - Install a free AC Unit. If it is determined, at the sole discretion of the contractor or the Utility Partners, that the residence does not meet the requirements or that the AC Unit would not materially improve the heat safety of the applicant, the applicant will not receive an AC Unit.
 - Install free basic energy-efficient products including but not limited to: LED light bulbs, weatherstripping, water-efficient shower heads, faucet aerators, and pipe wrap.
 - If during the free energy efficiency evaluation of my home, contractors determine that the property qualifies for further upgrades, I hereby grant permission to FortisBC and program contractors to conduct an advanced assessment on the property
 - I acknowledge and agree that FortisBC is not the designer, manufacturer or installer of the products installed under this program and that FortisBC makes no representation or warranty of any kind concerning such products or their installation or any potential cost savings there from. I further irrevocably waive any and all actions, claims, suits and demands (whether based in contract, tort, equity or otherwise) that I have or may in the future have against, and irrevocably release from liability and agree not to sue, FortisBC or any of its affiliates or any of its officers, directors, employees, agents, contractors or representatives for any type of loss or damage that I may suffer including, without limitation, property loss or damage, financial loss or damage, or personal injury that arise or accrue from, as a result of, in relation to, or in connection with my involvement in the program or the use and installation of these products.
 - I understand that any improvements to be performed in my home are subject to the availability of funds, program goals, and eligibility of the household under the program guidelines.
 - I have attached the most recent copy of a qualifying document for each member of the household 18 years of age and over and permit FortisBC to use this information to determine the total household income at the above residential property.
 - If I do not qualify for ECAP based on the information I have provided in this application, please use this information to determine my eligibility for the Energy Savings Kit (ESK) Program and/or the AC Unit Only Offer.
 - If I am a tenant, I understand that work cannot be completed in my home without the permission of my landlord and that it is my task to have my landlord complete the Landlord Consent Form and attach the completed form to my application.
 - If I am a tenant, I understand and agree that all energy efficient products installed and/or replaced in my home under the ECAP program, including but not limited to appliances, fixtures and all other improvements are the property of the building owner, and I will not remove or alter them.
 - I understand that, once installed, AC Units become the property of the applicant (whether a tenant or the owner) and as such they accept all responsibilities and liabilities related to the AC Unit, including those related to the repair, maintenance, replacement, and removal of the AC Unit.
- Consent to use information**
- I consent to FortisBC Energy Inc. and Fortis Inc. collecting, using and disclosing my personal information on this form for the purpose of administering ECAP and the AC Unit Only Offer, in accordance with the Personal Information Protection Act and FortisBC's Privacy Policy. If I have any questions regarding ECAP, and/or the information collection undertaken on this form, I can contact 1-866-436-7847.
 - I consent to FortisBC, and their contractors carrying out any necessary inquiry and to collect and use any information provided by me under this program for the purposes of administering, carrying out and evaluating the program including, without limitation, determining my eligibility to receive benefits under this program, conducting an evaluation of my home, recommending and installing energy efficient measures in my home, verifying compliance and conducting a quality assurance evaluation.
 - FortisBC may disclose my personal information to its contractors for the purposes of administering ECAP and the AC Only Offer. Disclosed information includes, but is not limited to: health and safety assessment results, products installed, photos of current and new equipment installed in the home and building information and I consent to information in accordance with the provisions of the Personal Information Protection Act.
 - I also consent to FortisBC's internal use of any information provided by me in this application and under this program, including electricity and natural gas consumption at the above household for a period of 36 months before program participation and 36 months after program participation, for purposes of:
 - administering and verifying the effectiveness of the program, and
 - expanding existing programs and designing new programs to better serve the needs of residential customers.
 - I understand that FortisBC may contact me (by phone, direct mail or similar method) for the purposes of program administration, implementation and evaluation and/or to provide me with further information on this or other similar conservation-related programs.
