Welcome & Opening Remarks

Remuneration of Council and Committee Members policy revisions

Council Leave of Absence policy

Council approved the internal governance policy regarding Council member leaves of absence. The policy provides guidelines and criteria to establish a transparent process for addressing leaves of absence for elected and appointed members of Council. <u>Click here</u> to review the policy.

Suitability to Practise policy revisions

The Registration Committee brought forward proposed revisions to the Suitability to Practise policy. The policy revisions are non-substantive in nature and include updating language (i.e., gender neutral), and removing reference to the Good Character policy. The Registration Committee recommended merging the *Suitability to Practise* and *Good Character* policy to reduce repetition and develop a more concise document. Council approved rescinding the Good Character policy. The *Suitability to Practise* policy can be found on the CRPO website.

Committee Appointments

Council approved the Executive Committee recommendations to appoint Michael Machan, RP, as Chair of the Registration Committee, replacing Andrew Benedetto, whose term ends on May 31, 2022. With M. Machan stepping into the role of Registration Chair, there is a need for a new Chair of the Nominations and Elections Committee. Council approved the appointment of Sherine Fahmy, public member, as Chair of the Nominations and Elections committee.

Council also appointed newly acclaimed District 7 (Central) Council member, Avni Jain, RP, to the Registration and Quality Assurance Committees. All members of Council sit on the Discipline and Fitness to Practise Committees. For full Council and Committee composition, click here.
