- No adult men are allowed on the property
- Unit size varies, but all include kitchen and bathroom
- Applicants must have steady income
- Monthly program fees range from \$325 - \$425 depending on the unit
- Residents are required to participate in case management
- Sober environment

TELLURIAN, INC.

- 20 double occupancy sober transitional housing units
- Applicants must have a mental health diagnosis or a concern with substance abuse
- Applicants must previously have had a lease in Dane County
- Monthly rent is \$650 and includes three meals daily, a snack, and the cost of laundry
- Shared bathrooms
- Residents are expected to apply for jobs and housing weekly
- Residents are required to meet with a human services assistant once a week, at minimum
- Residents must follow a curfew
- All residents' medications are monitored

PORCHLIGHT, INC.

- 14 single-room occupancy permanent housing units with shared bathrooms
- Applicants must have a mental health diagnosis and be experiencing homelessness (shelter, streets, or car)
- Monthly rent is \$400 and includes three meals daily and the cost of laundry
- Applicants do not need income to apply, however if/when housing is offered, applicants must then have a monthly income of at least \$800
- Waitlist times vary
- Residents may have visitors between 8:30am-6pm
- No visitors under the age of 18 are allowed

Applications must be completed in person at Safe Haven between 8:30am-6pm

- Monthly rent ranges from \$400 - \$770 depending on unit size (single-room occupancy, efficiency, or one bedroom)
- Shared bathrooms for single-room occupancy units
- Community kitchen and lounge
- Residents have access to a food and personal care pantry

- Free
- Program runs up to 12 months with mandatory case management and adherence to program rules
- Applicants cannot have a violent criminal history

Chandra's House of Hope

- Four furnished single-room occupancy sober living units for women in recovery from substance abuse
- Applicants must be at least 30 days sober and be employed or seeking gainful employment
- Shared kitchen and bathrooms
- Monthly rent is \$600 and includes parking, toiletries, the cost of laundry, and access to a fitness facility
- \$200 sober deposit required upon acceptance to the house
- Residents are not required to have income from work at move-in, however 30 days after move-in, residents must be employed and able to pay rent
- Residents must adhere to a curfew and other program rules
- Residents' medications are monitored

- Houses are separated by gender

- Rent varies depending on location; \$100 - \$110 a week on average
- \$200 - \$250 sober deposit required at move-in
- Houses are separated by gender

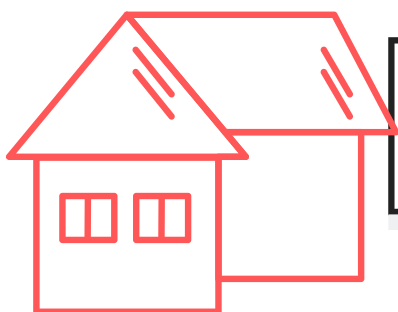
