

**Basic Subscription (\$50/year):** Includes the GIS map server, a complete index of all wells permitted in North Dakota in a Microsoft Excel spreadsheet saved with Zip compression. The scout ticket data contains basic well information, log tops, completion data, initial production tests, cumulative production and injection volumes, drill stem test recoveries. The well files are scanned into Adobe PDF documents that include all forms, letters, geological reports, drill stem test reports, core analysis reports, and other miscellaneous information. All well files are available, except for confidential wells or confidential information. Production and injection histories are available on a well, unit or field-pool basis.

**Premium Subscription (\$175/year):** Includes all information in the Basic Subscription, plus oil and gas field orders, scanned case files, hearing audio, digital and image well logs, cored intervals, core photographs, thin section photographs, stripper well determination assistant, and unitization statistics. ## **Instructions for website user agreement**

### **1. Complete/Update User Agreement:**

- For "User" please enter the **company name** if the USERID is to be used company wide. If the USERID will be only used by one person the "User" will be the name of the **single individual** authorized to use the USERID.
- The cost of the service will be **\$50.00 per year for the Basic Subscription** and **\$175 per year for the Premium Subscription**. Subscriptions start on the date the user agreement is processed by our office; process time can be 1 to 2 business days. Subscriptions are valid for one year from start date.

### **2. Submit User Agreement to Oil and Gas Division:**

### **3. Call to Provide Credit Card Payment or Mail in Check:**

- Checks can be mailed into the Oil and Gas Division office at the address below.
- DO NOT include credit card information on fax or emails.
- We accept most major credit cards (Visa, MasterCard, American Express, Discover)

### **4. Receive USERID and PASSWORD:**

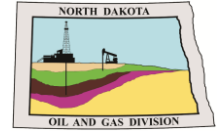
- USERID and PASSWORD will be sent to the e-mail address listed on the user agreement upon full payment and set up of service.

## Website User Agreement

\_\_\_\_\_ ("User") enters this agreement for the benefit of the Oil and Gas Division (Division) of the North Dakota Industrial Commission.

The Division agrees to provide User access to oil and gas data in return for User's payment of a subscription fee. The amount of this fee is dependent on the service option selected below and is subject to change.

The Division will provide User a USERID and password by which User may access the service. Only User is entitled to use the USERID and password. If User is an entity, such as an oil and gas company, its USERID and password may be used by any of its officers and employees. Excessive mining of data during normal business hours, any automated data mining activities that adversely affect normal server functions at any time, or any business practices that substantially duplicate OGD subscription services without adequately defraying the costs of providing such data under NDCC 38-08-04.6 may result in suspension of user access to our web site.
