Updates on rulemaking priorities: Sections 289.233 and 289.226, and 21R035 Rule Project for the medical use of radioactive material.

Mr. Vamvakias discussed the status of the radiation rules:

§289.233 rule was effective April 2021 and DSHS will start inspecting for compliance January 1, 2022. The department is working on guidelines to share with the stakeholders.

§289.226 rule is currently under DSHS review and some changes will be made.

§289.257 DSHS received comments from the TRAB Review Committee

§289.256 and 252 rules will be published in the Texas Register in September 2021.

Dr. Pate suggested to add an agenda item to discuss any legislative bills about radiation during the 2021 Texas Legislature. Ms. Forbes was asked to testify on a bill about radioactive waste, but the bill did not make it to the legislative floor.
