## **1. Introduction**

The European Labour Authority (hereafter 'ELA') is committed to protect your personal data and to respect your privacy. ELA collects and further processes personal data pursuant to [Regulation \(EU\) 2018/1725](#) of the European Parliament and of the Council of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data (repealing Regulation (EC) No 45/2001).

This privacy statement explains the reason for the processing of your personal data, the way we collect, handle and ensure protection of all personal data provided, how that information is used and what rights you have in relation to your personal data. It also specifies the contact details of the responsible Data Controller with whom you may exercise your rights, the Data Protection Officer and the European Data Protection Supervisor.

The information in relation to processing operation "*DPR-ELA-2023-0019 ELA network services (internal and ELA Guest WiFi)*" undertaken by the European Labour Authority, Resources Unit, ICT Sector (ELA ICT Sector is presented below.

## **2. Why and how do we process your personal data?**

Purpose of the processing operation: The ELA ICT Sector collects and uses your personal information to provide Wi-Fi services for its premises.

The European Labour Authority (ELA) makes available for the benefit of persons who visit, work or are otherwise present in ELA premises in professional, educational or private grounds ('users') a direct and free or charge internet access service based on a Wi-Fi hotspot, and specifically the wireless network E-Guest.

Your personal data will not be used for an automated decision-making including profiling.

## **3. On what legal ground(s) do we process your personal data**

We process your personal data, because, according to Article 5(1)(a) of Regulation (EU)2018/1725, the processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the Union institution or body.

Legal basis:

Regulation (EU) 2019/1149 of the European Parliament and of the Council of 20 June 2019 establishing a European Labour Authority ([ELA Regulation](#)).

We do not process **special categories of personal data**, therefore Article 10 of the Regulation does not apply.

## **4. Which personal data do we collect and further process?**

In order to carry out this processing operation, the ELA ICT Sector collects the following categories of personal data:

- Userid
- User IP address
- Required service IP address
- Required Application type
- Start time

- Connection duration
- Logs

*Some of those data categories are obtained by the end-user directly (typically the userid on remote connections).*

*The provision of this personal data is mandatory to start the service with a well-identified user in order to associate the right authentication and authorization parameters to the connection. As a result, no anonymous access is allowed.*

*The remaining personal data are collected from the technical infrastructure, which allows the establishment of the connection or the duration of the connection based on the user's activity.*

The provision of personal data is mandatory to meet a legal obligation: ELA Regulation. If you do not provide your personal data, we will not be able to provide our services.

#### **5. How long do we keep your personal data?**

The ELA ICT Sector only keeps your personal data for the time necessary to fulfil the purpose of collection or further processing, namely for a maximum 6 months after your contract with ELA has expired.

#### **6. How do we protect and safeguard your personal data?**

All personal data in electronic format (e-mails, documents, databases, uploaded batches of data, etc.) are stored either on the servers of the European Labour Authority or of its contractors.

ELA's contractors are bound by a specific contractual clause for any processing operations of your data on behalf of ELA, and by the confidentiality obligations deriving directly from the General Data Protection Regulation in the EU Member States ('GDPR' [Regulation \(EU\) 2016/679](#).)

In order to protect your personal data, ELA has put in place a number of technical and organisational measures in place. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access, taking into consideration the risk presented by the processing and the nature of the personal data being processed. Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of this processing operation.

#### **7. Who has access to your personal data and to whom is it disclosed?**

Access to your personal data is provided to ELA staff responsible for carrying out this processing operation and to authorised staff according to the "need to know" principle. Such staff abide by statutory, and when required, additional confidentiality agreements.

In particular, all the data categories could be accessed by:

- ELA Staff responsible for the service and the intramural contractors associated with the service, individually identified in charge of the technical and/or organisational support.
- CERT-EU staff in case of a security incident or breach. The processing of personal data will be covered by Record "DPR-ELA-2023-0022 ELA security investigations".

*Please note that pursuant to Article 3(13) of the Regulation, public authorities (e.g. Court of Auditors, EU Court of Justice) which may receive personal data in the framework of a particular inquiry in accordance with Union or Member State law shall not be regarded as recipients. The processing of those data by those public authorities shall be in compliance with the applicable data protection rules according to the purposes of the processing.*

The information we collect will not be given to any third party, except to the extent and for the purpose we may be required to do so by law.

## **8. What are your rights and how can you exercise them?**

You have specific rights as a 'data subject' under Chapter III (Articles 14-25) of Regulation (EU) 2018/1725, in particular the right to access, your personal data and to rectify them in case your personal data are inaccurate or incomplete. Where applicable, you have the right to erase your personal data, to restrict the processing of your personal data, to object to the processing, and the right to data portability.

You have the right to object to the processing of your personal data, which is lawfully carried out pursuant to Article 5(1)(a) on grounds relating to your particular situation.

You can exercise your rights by contacting the Data Controller, or in case of conflict the Data Protection Officer. If necessary, you can also address the European Data Protection Supervisor. Their contact information is given under Heading 9 below.

Where you wish to exercise your rights in the context of one or several specific processing operations, please provide their description (i.e. their Record reference(s) as specified under Heading 10 below) in your request.
