REPORT OF THE AUDIT DIVISION ON THE NEBRASKA REPUBLICAN STATE CENTRAL COMMITTEE AND THE NEBRASKA REPUBLICAN FEDERAL CAMPAIGN COMMITTEE

I. Background

A. Overview

This report is based on an audit of the Nebraska Republican State Central Committee and the Nebraska Republican Federal Campaign Committee undertaken by the Audit Division of the Federal Election Commission in accordance with the Commission's audit policy to determine whether there has been compliance with the provisions of the Federal Election Campaign Act of 1971, as amended ("the Act"). The audit was conducted pursuant to Section 438(a)(8) of Title 2, of the United States Code, which directs the Commission to make from time to time audits and field investigations with respect to reports and statements filed under the provisions of the Act.

The Nebraska Republican State Central Committee (NRSCC) registered with the U.S. General Accounting Office on April 17, 1972, as a state committee of the Republican Party of Nebraska. The NRSCC maintained its headquarters in Lincoln, Nebraska. The Nebraska Republican Federal Campaign Committee (NRFCC) registered with the Federal Election Commission on May 27, 1976, as a state committee of the Republican Party of Nebraska. The NRFCC maintains its headquarters in Lincoln, Nebraska.

The audit of the NRSCC covered the period January 1, 1976, through May 31, 1976, the final coverage date of the last report filed. During the period the NRSCC reported a beginning cash balance of \$6,578.72, total receipts of \$61,376.49, total expenditures of \$64,473.85 and a closing cash balance of \$3,481.36. The audit of the NRFCC covered the period from the date of inception, May 12, 1976, through March 31, 1978, the final coverage date of the most recent report filed by the NRFCC at the time of the audit. The NRFCC reported a beginning cash balance of \$-0-, total receipts of \$81,563.65, total expenditures of \$80,603.45 and a closing cash balance on March 31, 1978, of \$960.20.

This audit report is based on documents and working papers which support each of the factual statements. They form part of the record upon which the Commission based its decisions on the matters in the report and were available to Commissioners and appropriate staff for review.

B. Key Personnel

The principal officers of the Committees during the period audited were Milan D. Bish, Chairman (NRSCC); Wyman B. Kenagy, Chairman (NRFCC) and Dale Young, Treasurer.

C. Scope

The audit included such tests as verification of total reported receipts and expenditures and individual transactions; review of required supporting documentation; analysis of Committee debts and obligations; and, such other audit procedures as deemed necessary under the circumstances.

II. Audit Findings and Recommendations

Certain matters noted during the audit were referred on June 14, 1978, to the Commission Office of General Counsel for consideration.
