REPORT OF THE AUDIT DIVISION ON THE CONSTRUCTIVE CITIZENSHIP PROGRAM

I. Background

A. Overview

This audit report is based on an audit of the Constructive Citizenship Program ("the Committee"), undertaken by the Audit Division of the Federal Election Commission in accordance with the Commission's audit policy, to determine whether there has been compliance with the provisions of the Federal Election Campaign Act of 1971, as amended ("the Act"). The audit was conducted pursuant to Section 438(a)(8) of Title 2 of the United States Code, which directs the Commission to make from time to time audits and field investigations with respect to reports and statements filed under the provisions of the Act.

The Committee registered with the United States House of Representatives on May 5, 1972, as the corporate political action committee connected to Texas Instruments, Inc.

The audit covered the period from January 1, 1977 through September 30, 1979, the final coverage date of the latest report filed by the Committee at the time of the audit. The Committee reported a beginning cash balance on January 1, 1977 of \$9,583.93, total receipts for the period of \$22,257.03, total expenditures of \$23,719.88, and a closing cash balance on September 30, 1979, of \$8,121.08.

This audit report is based on documents and working papers which support each of its factual statements. They form part of the record upon which the Commission based its decisions on the matters in this report and were available to Commissioners and appropriate staff members for review.

B. Key Personnel

The principal officers of the Committee during the period covered by the audit were Mr. A. Ray McCord, Chairman and Mr. Liston M. Rice, Jr., Treasurer.

C. Scope

The audit included such tests as verification of total receipts and expenditures and individual transactions; review of required supporting documentation; analysis of Committee debts and obligations; and, such other audit procedures as deemed necessary under the circumstances.

II. Finding and Recommendation

Based upon examination of the reports and statements filed and the records presented by the Constructive Citizenship Program, no material problems in complying with the Federal Election Campaign Act were discovered during the course of the audit.
