A. Overview

This report is based on an audit of the Committee For Thorough Agricultural Political Education ("the Committee") undertaken by the Audit Division of the Federal Election Commission in accordance with the Commission's audit policy to determine whether there has been compliance with the provisions of the Federal Election Campaign Act of 1971, as an an and def ("the Act"). The audit was conducted pursuant to Section 438(a)(8) of Title 2 of the United States Code which directs the Commission to make from time to time audits and field investigations with respect to reports and statements filed under the provisions of the Act.

The Committee registered with the Office of the Clerk of the United States House of Representatives on April 17, 1972. The Committee maintains its headquarters in San Antonio, Texas.

The audit covered the period from January 1, 1977 through July 31, 1979, the final coverage date of the latest report filed by the Committee at the time of the audit. The Committee reported a beginning cash balance on January 1, 1977 of \$1,216,115.86; total receipts for the period of \$1,270,297.63; total expenditures for the period of \$1,246,323.11; and a closing cash balance on July 31, 1979 of \$1,240,090.38.
