## **Federally Employed Women's (FEW) Voting Record Scorecard for the 115<sup>th</sup> Congress—Second Session**

Dear FEW Members:

The second session of the 115th Congress mostly saw breakdowns in the legislative process and Congress's inability to function. It was extremely difficult for Congress to carry out its most basic functions, the budget and appropriations processes.

The House did however, pass all 12 regular appropriations bills in an omnibus bill, but the Senate took no action. Congress enacted a series of three continuing resolutions to keep the government funded at current levels for a limited period of time.

It is gravely unfortunate that during the second session of Congress, in the eleventh hour, the 115th Congress failed to agree on a funding bill resulting in a partial government shutdown, affecting seven government agencies and 800,000 federal employees. This shutdown is a direct result of an impasse over \$5 billion in funding for a wall to secure the southern border, which passed in the House but lacked the votes to pass in the Senate. Those seven agencies remained closed as of this writing.

The 115th Congress ultimately passed four bills relating to women's issues, promoting women's involvement in international peacemaking, space exploration, and entrepreneurship. Congress also passed a highly controversial bill allowing states to withhold funding for Planned Parenthood. It was the second of many Senate votes which ended with a tiebreaker from Vice President Mike Pence. Senators Lisa Murkowski (R-AK) and Susan Collins (R-ME), both voted against the bill, which forced the tiebreaker vote.

I am pleased to report that a significant government oversight bill we were monitoring was passed by the 115th Congress to reform the procedures for protecting the rights of Congressional employees, in particular from sexual harassment. The bill was passed three months after former congressional employees who had experienced harassment in Congress wrote an open letter calling for action.

In this FEW Scorecard of the second session of the 115<sup>th</sup> Congress are two recorded votes acted upon by the House of Representatives and three votes in the U.S. Senate. Although these issues were scored they are not considered as FEW's "key-votes". As you are aware, we rate lawmakers based on their vote/actions on the bills that are identified in the three tiers of the legislative agenda.

In this session members were scored on legislation that was considered to have an impact on the federal workforce, or in-line with issues that FEW has taken a position on. You will also note that several bills that FEW supports, that are "Key" were introduced. Those bills are pending further legislative action. FEW will continue to monitor those bills throughout the legislative process.

Also, highlighted in this Scorecard are the Congressional Members in the United States Senate and United States House of Representatives who were in alignment with FEW on the legislative issues that received a vote in the second session of the 115<sup>th</sup> Congress. FEW extends a special "Thank-You" to these members for their support. This list does not include all who have been and continue to support these issues.

FEW encourage you to examine the current and past voting record of your representative. Simply, look up your legislators and contact them about their votes and decisions regarding their votes and co-sponsorships. (To find out who your legislators are, visit ENGAGE and type in your zip code under the Elected Officials link.)

While this voting record is an important tool in monitoring the actions of Congress, it is important to recognize that it is not the sole reflection of a legislator's record. Furthermore, it is neither an endorsement nor a condemnation of any Member of Congress.

# House Votes/Actions

## Roll Call Votes Recorded – 115<sup>th</sup> Second Session of Congress

**[1] H.Con.Res.71 - Establishing the congressional budget for the United States Government for fiscal year 2018 and setting forth the appropriate budgetary levels for fiscal years 2019 through 2027.**

*October 5, 2017*

*Fiscal Year 2018 Budget Resolution (H.Con.Res. 71)*

FEW opposed this budget resolution, which instructed the House Committee on Oversight and Government Reform (OGR) to find at least \$32 billion in savings over 10 years from mandatory spending under the committee's jurisdiction. As the only substantial mandatory spending under OGR's jurisdiction comes from federal retirement and health benefit programs, such instructions would target those programs. The House Budget Committee report on the resolution outlines specific policies to achieve its proposed savings, including: increasing retirement contributions for current federal employees, limiting the rate of return on the Thrift Savings Plan's Government Securities fund, limiting the government's portion of Federal Employees Health Benefits premiums, ending the Federal Employees Retirement System (FERS) Annuity Supplement and increasing the postal employee share of FEHB contributions. The resolution was adopted by a vote of 219-206.

**[2] S.3749 - Congressional Accountability Act of 1995 Reform Act**

*December 13, 2018*

*Congressional Accountability Act of 1995 Reform Act (S.3749)*

FEW supported this Amendment which amends the Congressional Accountability Act of 1995 to reform the procedures provided under such Act for the initiation, review, and resolution of claims alleging that employing offices of the legislative branch have violated the rights and protections provided to their employees under such Act, including protections against sexual harassment, and for other purposes.

Senate Rules and Administration Chairman Roy Blunt of Missouri led the passage of the bill, by unanimous consent. Blunt worked with the panel's ranking member, Sen. Amy Klobuchar, D-Minn., along with party leaders and several House members on the deal. S.3749 passed House without amendment (02/06/2018).

"While this compromise with the Senate is a good first step, House Republicans and Democrats remain committed to working in a bipartisan manner to address outstanding issues in the 116th Congress, including passing legislation which holds Members personally liable for discrimination, reauthorizing the Employee Advocate, and strengthening our workplace rights and responsibilities education program," said House Administration Committee Chairman Greg Harper, Robert Brady, Paul D. Ryan, Nancy Pelosi, Bradley Byrne and Jackie Speier in a statement Wednesday night.

*Appropriations Minibus (H.R. 6147)*

FEW supported this bill because it would increase pay rates for civilian federal employees by 1.4 percent across-the-board, and increase locality pay rates by an average of 0.5 percent, in January 2019. The pay increase was included in a package of four appropriations bills bundled into one “minibus,” H.R. 6147. The bill passed by a vote of 92-6.

### **[2] H.R.1892 – Bipartisan Budget Act of 2018**

*February 9, 2018*

*Bipartisan Budget Act of 2018 (H.R. 1892)*

FEW supported this legislation because it lifted sequestration caps on spending levels for fiscal years 2018 and 2019, without using reductions in federal pay or benefits as an offset. The legislation also extended fiscal year 2017 funding levels through March 23, 2018, to avoid another government shutdown. The bill passed by a vote of 71-28.

### **[3] S.3749 - Congressional Accountability Act of 1995 Reform Act**

*December 13, 2018*

*Congressional Accountability Act of 1995 Reform Act (S.3749)*

FEW supported this Amendment which amends the Congressional Accountability Act of 1995 to reform the procedures provided under such Act for the initiation, review, and resolution of claims alleging that employing offices of the legislative branch have violated the rights and protections provided to their employees under such Act, including protections against sexual harassment, and for other purposes.

Senate Rules and Administration Chairman Roy Blunt of Missouri led the passage of the bill, by unanimous consent. Blunt worked with the panel's ranking member, Sen. Amy Klobuchar, D-Minn., along with party leaders and several House members on the deal. S.3749 passed House without amendment (02/06/2018).

"While this compromise with the Senate is a good first step, House Republicans and Democrats remain committed to working in a bipartisan manner to address outstanding issues in the 116th Congress, including passing legislation which holds Members personally liable for discrimination, reauthorizing the Employee Advocate, and strengthening our workplace rights and responsibilities education program," said House Administration Committee Chairman Greg Harper, Robert Brady, Paul D. Ryan, Nancy Pelosi, Bradley Byrne and Jackie Speier in a statement Wednesday night.
