RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT

Dear Ms. Villalvir del Cid:

Please be advised that as of 18 September 2013, Tecnologia, Desarrollo Y Mercado S. de R.L. de C.V. ("TDM") is in breach of its Registrar Accreditation Agreement ("RAA") with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 30 November 2011. These breaches result from:

1. TDM's failure to enter into registration agreements with Registered Name Holders of domain names as required by Section 3.7.7 of the RAA.

Please refer to the attachment for details regarding this breach.

ICANN requests that TDM cure the breaches by 9 October 2013, 15 working days from the date of this letter, by taking the following actions:

1. Provide corporate records and documentation demonstrating that TDM's Privacy Protection Service is a separate legal entity, as required by Section 3.7.7 of the RAA.

If TDM fails to timely cure these breaches and provide the information requested by 9 October 2013, ICANN may commence the RAA termination process.

## **ATTACHMENT**

Failure to Enter into Registration Agreement with Registered Name Holders

Section 3.7.7 of the RAA requires TDM to enter into a registration agreement with all Registered Name Holders for domains under TDM's management, except those domains used for the purposes of Registrar Services.

As detailed in the chronology below, ICANN sent multiple notices to TDM requesting registration data, records, and corporate documents regarding TDM's Privacy Protection Service, sufficient to demonstrate that it is a legal entity operating independently from the registrar. TDM provided registration data and records, but to date has not provided corporate documents demonstrating that TDM's Privacy Protection Service is a separate legal entity.

8 July 2013	N/A	ICANN attempted to call Registrar Primary Contact at all numbers in RADAR (+504 2510 2358, +504 9955 4559, and +504 3320 0548). All numbers were disconnected or did not exist.  ICANN attempted to call the numbers listed on the Registrar's website (+504 4086888 and +504 3384 8637) and received messages the numbers were invalid or did not exist.  ICANN attempted to call the mobile phone number listed on Registrar's website +504 9561 1257 and left a voicemail. There was no message identifying the Registrar, only a recording requesting the caller to leave a message.

25 July 2013	N/A	Registrar responded to follow-up to 3 <sup>rd</sup> compliance notice, requesting that ICANN communicate with its back-end provider and legal representative regarding this matter.
