## 30-Hour Problem Gambling Counselor Certification Training



As gambling continues to expand in Kentucky, and as the first publicly funded program of Problem Gambling Education, Prevention and Treatment starts in 2024, the Kentucky Council on Problem Gambling is pleased to announce a 30-Hour program that meets the classroom training requirements to attain Gambler Counselor Certification Level One (CCGC-I) from the International Gambling Counselor Certification Board (IGCCB). Participants in the 30-Hour training will be able to pursue certification and be prepared for the required examination.

*The 30-Hour training program will be held at Blue Licks Battlefield State Resort Park January 22-26, 2024. The training agenda is shown at the right. Certified and nationally recognized presenters will lead all sessions following IGCCB guidelines.*

**KYCPG has arranged to present the 30-Hour training program at no charge for the first 40 approved registrants.** Travel costs are the registrants responsibility. Applicants are to complete this registration form, including providing a statement of the reason for participating and how the knowledge and certification will be used in practice.

Participant double occupancy housing for four nights will be provided at no charge. A single-room upgrade for the four nights is available at a total cost of \$150 payable to KYCPG at registration. Daily breakfast, lunch, dinner and breaks, and any training materials, will be provided at no charge to participants.

**Registrations must be received by December 29, 2023.** Each registration form will be reviewed by a committee of KYCPG's officers and IGCCB-certified counselors. Employment citations may be verified. Those accepted will be notified by e-mail the week of January 1, 2024.
