

Dear Colleagues,

I am excited to share this Clinical Programs and Experiential Learning newsletter with you, starting by introducing Georgetown Law's newest clinic, the Civil Justice Clinic, directed by Professor Llezlie Green. This year we are also celebrating the careers of three clinical faculty and the 50th anniversary of our Juvenile Justice Clinic - founded by Wally Mlyniec, L'70 in 1973. You'll also read about the recent work of one of our 18 inhouse clinics, the Intellectual Property and Information Policy Clinic, where students are developing critical skills in client advocacy while tackling unprecedented questions of technology and justice.

Georgetown Law continues to provide a rich array of additional experiential learning courses, scheduling over 35 practicum courses each year. This year, students will work on projects involving climate change, child welfare in the District of Columbia, wrongful convictions, domestic terrorism, mitigating the impact of armed conflict and atrocities on civilians and victims, addressing human rights violations and much more. Another 400 students will earn credit through the J.D. Externship program for fieldwork with judges, at federal agencies, and at nonprofits. Over 1600 students will partake in our simulation courses, exploring topics such as restorative justice, the intersection of AI and legal practice, and legal responses to cyber security incidents.

We regularly host delegations from around the world who study our clinical and experiential learning successes. You can read below about the latest delegation's visit to Georgetown Law from Moldova.

Finally, I would like to highlight the recent issue of the the Clinical Law Review, devoted

to articles from Georgetown Law's 2023 Symposium on "<u>Promoting Justice: Advancing</u> Racial Equity Through Student Practice in Legal Clinics."

The issue contains articles and essays from clinical faculty who participated in the symposium, including from some of our tenure-track clinical faculty--Yael Cannon, Laura Moy, Vida Johnson, and Janel George--and from visiting professor Eduardo Ferrer and adjunct professor Jennifer Li. The articles demonstrate the depth of racial justice lawyering and teaching that each of them are accomplishing in their clinics. I'm so proud to call these folks my colleagues! 
Delegation Travels from Moldova to Visit Georgetown Clinical Faculty

This September, a delegation of legal clinic representatives traveled from Moldova to Washington D.C. to study the structure of successful clinics in the U.S. The delegation included the leader of the Moldovan National Legal Aid Council and was accompanied by the American Bar Association Rule of Law Initiative. Georgetown Law clinical faculty members Wally Mlyniec, L'70 and Llezlie Green shared their expertise on the history of clinical programs at the university and the crucial considerations for structuring a new clinic. After their week-long study tour of legal clinics, the delegation returned to Moldova to work on implementing key takeaways within their local legal frameworks.



New Civil Justice Clinic seeks economic justice for low-income clients

In Spring 2024, Georgetown Law's new Civil Justice Clinic will commence its inaugural semester. The Clinic will advocate for clients' economic justice interests and seek to provide representation to those who otherwise would remain voiceless in the legal system. Students will primarily provide legal services to low-income clients who have suffered exploitation such as wage theft, but the Clinic will also take unemployment benefit appeals and other cases involving employment, public benefits, consumer, and housing matters. In learning through the lens of economic justice, students will grapple with issues related to how the law intersects with the economic viability of clients, and particularly its impact on low-wage workers, Clinic Director Llezlie Green said. Over the past 50 years, Georgetown Law's Juvenile Justice Clinic has changed countless lives through its representation of the District of Columbia's youth. The Clinic, founded in 1973, is the oldest continuously operating juvenile clinic in the country. Its impact on juvenile justice advocacy and clinical teaching has touched the lives of decades of students and clients and stretches internationally. In June 2024, Clinic alumni will return to Georgetown to celebrate the Clinic's fiftieth anniversary, look back on its achievements, and look ahead to its future endeavors. [Read more]







Congratulations to three esteemed clinical faculty on their retirement

In September, Georgetown Law celebrated the retirement of three members of its esteemed clinical faculty: Professor Hope Babcock, Professor Angela Campbell, L'83, and Professor Steven Goldblatt, L'70. All three were key in shaping Georgetown's clinical programs and pedagogy. Their numerous and invaluable accomplishments are highlighted below.

Professor Hope Babcock

Professor Babcock led the Institute for Public Representation's Environmental Law Clinic—now known as the Environmental Law and Justice Clinic—for more than three decades. Her work was foundational in shaping environmental law policy, and she participated in several landmark environmental law cases throughout her career. During her tenure as clinic director, Professor Babcock led students in representing clients' interests in environmental and public health law. The clinic litigated and filed amicus briefs involving claims under the Endangered Species Act, National Environmental Policy Act, Land and Water Conservation Fund Act, Clean Air Act, and more, including bringing the first case under the District of Columbia's Environmental Policy Act. Under her leadership, the clinic was recognized for its contributions to the environment by the Department of the Interior and the Environmental Protection Agency.

Professor Angela Campbell, L'83

Professor Campbell directed the Institute for Public Representation's Communications & Technology Law Clinic for 31 years. While at the helm of the clinic, she led students in representing non-profit organizations before the Federal Communications Commission, Federal Trade Commission, and federal courts to advocate for public media policies in the public interest. She played an integral role in the adoption, implementation, and enforcement of the Children's Online Privacy Protection Act, a landmark digital privacy law. Along with advocacy of children's online privacy protection, her clinical work championed diversifying media ownership, increasing media access to persons with disabilities, and making broadcast stations accountable to the public. She argued and won cases before federal Courts of Appeals, filed several amicus briefs before the Supreme Court, and testified before Congress on different media and privacy issues.

Professor Steven H. Goldblatt, L'70

Professor Goldblatt directed the Appellate Litigation Clinic for more than 30 years and co-founded Georgetown Law's Supreme Court Institute in 1999. While leading the clinic, Professor Goldblatt argued four clinic cases before the Supreme Court and litigated several cases before the United States Courts of Appeals for the D.C. and the Fourth Circuits. His work shaped the Appellate Litigation Program into one of the Law Center's core experiential education programs, through which hundreds of students have learned the intricacies of appellate advocacy. Additionally, as a result of his work as co-founder and Faculty Director of the Supreme Court Institute, countless Georgetown Law students have received insight on the process behind lawyering at the highest level in the nation. The law school honored Professor Goldblatt in 2019 with the Steven Goldberg Faculty Service Award to recognize his contributions to the Georgetown Law community.
