Representative Ogren called attention to the revised Committee procedures and the revised Committee Member Listing enclosed in each members' folder. He stressed that they contact the House Research people to draft amendments for them.

Representative Ogren stated that he has referred House File 1381 (Clark) to the Physical/Mental Health Subcommittee. This bill would require training for employees in nursing homes and correction facilities for exposure to infectious agents.

Representative Ogren also stated he was in the process of appointing members to a task force to study the long term future of Regional Treatment Centers. Representative Peter Rodosovich will chair the task force.

Representative Ogren indicated that two hearings are planned for the November Mini Session in Alexandria. One would be with a resident council in an Osakis nursing home and the second meeting would be held to hear testimony on Rule 38, the licensing rule for DAC's.

Whereas the quality of such programs is dependent on educated public health nurses, and

and cost effective community health service programs, and

Whereas the University of Minnesota provides the only graduate level public health nursing program in the state, and

Whereas certified public health nurses prepared in baccalaureate nursing programs help assure that Minnesota citizens receive quality, cost effective care by conducting nursing home preadmission screening, functioning as case managers for high risk clients and performing skilled nursing assessments;

Therefore be it resolved that the health and Human Services Committee of the Minnesota House of Representatives goes on record and strongly urges the Regents of the University of Minnesota that --

- the University of Minnesota graduate public health nursing program be maintained at least at the current levels of funding and programming and not be eliminated;
- the University of Minnesota School of Nursing current and planned decrease in size to 80 positions be re-examined in relationship to Minnesota's growing demand for professional nursing services, the current and anticipated nurse shortage, and that consideration be given to expanding, not decreasing frontline baccalaureate nurse positions.
