1. Effective January 4, 1993, the salaries of all covered constitutional officers, Judges and member of the legislature shall be:

2. Effective January 3, 1994 the salaries of all covered constitutional officers, Judges and members of the legislature shall be those salaries enumerated above under recommendation number one.

3. It is suggested that the Legislature review M.S.A. 15A.082 in its entirety, specifically re-evaluating the dates incorporated therein for deadlines and the effective date for implementing the Council's recommendations. It appears to the Council that difficulties are created for both the executive and legislative branches in budgeting on a fiscal year basis and implementing salary changes on a calendar year basis.
