## **REPORTS OF STANDING COMMITTEES**

Mr. French from the Committee on Civil Administration to which was referred:

H. F. No. 498, A bill for an act relating to employees of certain public hospitals, members of the public employees retirement association, and providing for coverage under the old age, survivors, and disability insurance provisions of Title II of the federal social security act, and appropriating money therefor; amending Laws 1963, Chapter 793, Sections 13, Subdivisions 1, 2, and 3; 14, Subdivision 1; 15; 17, Subdivision 2; 19.

Reported the same back with the following amendments:

Section 1, line 11, after the word "salary" and before the period insert "not in excess of \$6,000 in any calendar year". In line 14 strike the new word "total" and after the word "received" reinsert the stricken language, and when reinserted strike the figure "\$4,800" and insert in lieu thereof "\$6,000". In line 15 strike "from all sources".

Page 2, line 1, after "salary" and before the period insert "not in excess of \$6,000 in any calendar year".

Section 3, line 8, after "member" and before the comma insert "not in excess of \$6,000 in any calendar year".

Page 3, line 1, after "salary" and before "for" insert "not in excess of \$6,000 for any calendar year". In line 4, reinsert the stricken paragraph "(c)" and when reinserted strike the figure "\$4,800" and insert in lieu thereof "\$6,000".

Page 4, line 9, after the word "salary" and before the comma insert "not in excess of \$6,000 in any calendar year".

With the recommendation that when so amended the bill do pass and be placed on the Consent Calendar.
