SENATE RESOLUTION NO 9.

A Resolution providing for legislative expense for members of the Senate.

Whereas, the cost of living is high and the expenses of the members of the Legislature considerable while attending legislative sessions away from their customary place of business and home, and

Whereas, the expenses of the legislator not only accrue during the session but throughout the interim because of the many services he performs for his constituents,

Now, Therefore, Be It Hereby Resolved, that the Secretary is hereby authorized and directed to prepare and issue warrants in payment of expenses of members of the Senate from the legislative expense fund for the expenses of said members for 1953 session of the legislature in the sum of \$1200 to each member of the Senate.

Which Resolution was referred to the Committee on Rules and Legislative Expense.

Messrs. Feidt and Gillen introduced—

SENATE CONCURRENT RESOLUTION NO. 26.

A Concurrent Resolution relating to bill drafting between sessions by the revisor of statutes.

Whereas, prior to and during the 1953 session of the legislature the revisor of statutes was authorized to draft bills for the members of the legislature and money was appropriated to him to be expended for the employment of the necessary personnel required to perform such services, and

MESSAGE FROM THE HOUSE—CONTINUED.

Mr. President:

I have the honor to announce that the House accedes to the request of the Senate for the return of Senate File No. 1737 for further consideration:

S. F. No. 1737: A bill for an act to appropriate money for the payment of claims against the state of Minnesota; to provide for tax and other refundments; to provide for reimbursement and compensation of certain employees of the state having claims for personal injuries or for loss or damage of property incurred while employees were engaged in the performance of their duties; and for the relief of dependents of certain employees of the state for the death of such employees while engaged in the performance of their duties; to provide for the reimbursement and compensation of persons for injuries sustained or for loss or damage to property by certain employees of the state while engaged in the performance of their duties; and by inmates of state institutions; and to provide payments to certain persons for services performed in the state; to authorize the State Auditor to cancel certain land and other contracts heretofore entered into by certain persons with the state and to credit payments heretofore made upon other purchases or to refund same; to provide money for carrying on certain state activities as authorized by law; to authorize and direct certain claims to be paid out of Game and Fish funds; to authorize and direct certain claims to be paid out of Department of Agriculture funds; to authorize and direct certain claims to be paid out of gas tax refunds account; permitting suits against the State of Minnesota in certain cases; authorizing establishment of commissions to investigate certain claims and to compromise or settle such claims; and reappropriating certain balances; directing and empowering the Attorney General and the Commissioner of Highways to settle certain claims; and for other purposes.
