COMMITTEE ON RULES AND LEGISLATIVE ADMINISTRATION

MEMBER EXPENSE REIMBURSEMENT LIMITS

BE IT RESOLVED, by the Committee on Rules and Legislative Administration, that the House Controller is hereby authorized and directed to prepare and issue warrants in payment of living expenses to each member of the House from the Legislative Expense Fund each calendar day of the Sessions of the 80th Legislature.

BE IT FURTHER RESOLVED, that each member of the House who has moved from his or her usual place of lodging for a substantial part of the Sessions of the 80th Legislature shall be reimbursed up to \$735.00 per month for his or her actual lodging expenses during the Sessions of the 80th Legislature. The term "lodging expenses", includes, in addition to rent, the following lodging-related expenses at the place of lodging: furniture rental, local telephone service, utilities, renter's insurance and parking. Each member requesting reimbursement shall file the member's housing contract with House Administrative Services and shall include a receipt or other verification of payment, with each monthly request for reimbursement.

PROVIDED FURTHER, each House member requesting the housing reimbursement under this resolution shall certify in writing to the House Controller, prior to the issuance of the first monthly warrant for each of the Sessions of the 80th Legislature, that he or she has moved from the usual place of lodging and is eligible for the housing reimbursement authorized by this resolution.

PROVIDED FURTHER, that each member of the House shall be paid per diem living expenses in an amount up to \$56.00 for each calendar day during the Sessions of the 80th Legislature.

PROVIDED FURTHER, that each member who has moved from his or her usual place of lodging for the Sessions of the 80th Legislature shall in addition be reimbursed for travel to and from their homes at the same rate per mile as the standard federal mileage rate, not to exceed one round trip per week of the Sessions.

PROVIDED FURTHER, that each member of the House who resides more than 125 miles from the State Capitol may be reimbursed for the actual expense of air travel between his or her place of residence and the State Capitol in lieu of actual mileage for such travel, upon presentation of a voucher. During sessions, a qualifying member is entitled to this reimbursement; during interims, a qualifying member may be reimbursed only with the approval of a Committee Chair or the Speaker.

PROVIDED FURTHER, that when a member or employee is traveling within the state on business of the House of Representatives, reimbursement for lodging shall not exceed \$70.00 per night. However, when members or employees are attending a mini-session or conference within the state, they may be reimbursed up to \$85.00 per night at the site of the mini-session or conference.

PROVIDED FURTHER, that during the 1997 and 1998 interims of the 80th Legislature each member may receive, upon written request, a legislative district travel allowance based upon the actual size of his or her legislative district. Such allowance shall be computed at the standard federal mileage rate per square mile per month with a minimum of \$60.00 and a maximum of \$550.00 per month.

PROVIDED FURTHER, that during the 1997 and 1998 sessions and during the interims, the Speaker's advance approval is required for per diem and re-reimbursement of expenses for all out-of-state travel by a member or employee.

CRLAR97-2 PAGE THREE PROVIDED FURTHER, that during the 1997 and 1998 interims, for travel away from the members home, and with the approval of a Committee Chair or the Speaker, members shall be reimbursed for actual expenses in the same manner as state employees in addition to per diem expense allowances. During sessions and interims, no member shall receive reimbursement for food expenses on any day that per diem is paid. TED WINTER, CHAIR
