# **RESOLUTION ON MEMBER EXPENSE REIMBURSEMENT LIMITS**

8 BE IT RESOLVED, by the Committee on Rules and Legislative Administration, that the 9 House Controller is authorized and directed to prepare and issue warrants in payment of living 10 expenses to each member of the House from the Legislative Expense Fund each calendar day of 11 the Sessions of the 81st Legislature.

PROVIDED FURTHER, that each member of the House who moves from his or her 13 14 usual place of lodging for a substantial part of the Sessions of the 81st Legislature must be 15 reimbursed for the member's actual lodging expenses during the Sessions of the 81st Legislature, <sup>•</sup>6 up to the following amounts per month: \$757 in 1999, and \$780 in 2000. The term "lodging 17 expenses" includes, in addition to rent, the following lodging-related expenses at the place of 18 lodging: furniture rental, local telephone service, utilities, renter's insurance and parking. Each 19 member requesting reimbursement shall file the member's housing contract with House 20 Administrative Services and shall include a receipt or other verification of payment, with each 21 monthly request for reimbursement. Each member requesting the lodging reimbursement shall 22 certify in writing to the House Controller, before the issuance of the first monthly warrant for 23 each of the Sessions of the 81st Legislature, that he or she has moved from the usual place of 24 lodging and is eligible for the lodging reimbursement authorized by this resolution.

5 PROVIDED FURTHER, during the Sessions of the 81st Legislature, a member may be reimbursed for the expense of overnight lodging in the vicinity of the Capitol Complex on a night 27 28 when the member is required to remain at the Capitol Complex to conduct legislative business or 29 for reasons of safety. The reimbursement may not exceed \$70.00 per night. The reimbursement 30 request must be in writing, accompanied by a receipt or other verification of payment, and 71 approved by the Speaker.

PROVIDED FURTHER, that each member of the House, upon request, must be paid per diem living expenses in an amount up to \$56.00 for each calendar day during the Sessions of the 81st Legislature.

5 PROVIDED FURTHER, that each member of the House who moves from his or her 6 usual place of residence for the Sessions of the 81st Legislature must be reimbursed for travel to 7 and from the member's place of residence at the same rate per mile as the standard federal mileage 8 rate, not to exceed one round trip per week of the Sessions.

PROVIDED FURTHER, that each member of the House who resides more than 125 miles from the State Capitol may be reimbursed for the actual expense of air travel between his or her place of residence and the State Capitol instead of actual mileage for the travel, upon presentation of a voucher. During sessions, a qualifying member is entitled to this reimbursement upon request; during interims, a qualifying member may be reimbursed only with the approval of a Committee Chair or the Speaker.

PROVIDED FURTHER, that when a member or employee is traveling within the state on the business of the House of Representatives, reimbursement for lodging may not exceed \$70.00 per night. However, when members or employees are attending a mini-session or conference within the state, they may be reimbursed up to \$85.00 per night at the site of the mini-session or conference.


PROVIDED FURTHER, that during the 1999 and 2000 interims of the 81st Legislature
each member of the House may receive, upon written request, a legislative district travel
allowance based upon the actual size of his or her legislative district. The allowance must be
computed at the standard federal mileage rate per square mile per month, with a minimum
allowance of \$60.00 and a maximum allowance of \$550.00 per month.

PROVIDED FURTHER, that during the 1999 and 2000 sessions and during the interims
 of the 81st Legislature, the Speaker's advance approval is required for per diem and re reimbursement of expenses for all out-of-state travel by a member or employee.

PROVIDED FURTHER, that during the 1999 and 2000 interims, a member of the House who is traveling away from the member's home with the approval of a Committee Chair or the Speaker must be reimbursed for actual expenses in the same manner as state employees. The reimbursement is in addition to per diem expense allowances. During sessions and interims, a member may not receive reimbursement for food expenses on any day that the member receives per diem.
