Senator Roger D. Moe, Chairman of the Senate Committee on Rules and Administration, called the meeting to order at 11:25 a.m. on Monday, February 1, 1999, in Room 107 of the State Capitol.

A quorum was present.

Senator Moe presented resolution SC6062 relating to mileage, living, and telecommunication expenses incurred by members of the Senate (see resolution SC6062). Senator Solon moved adoption of the resolution. The **MOTION PREVAILED**.

Senator Junge presented a report outlining the findings and conclusions of the Subcommittee on Ethical Conduct pertaining to Senator Dallas Sams' work as a consultant for Media Integrated Training Services (MITS), as part of a contract between MITS and the University of Minnesota College of Agricultural, Food, and Environmental Sciences (COAFES), and whether or not said contract constituted a conflict of interest (see Advisory Opinion dated 1-29-99).

Senator Frederickson outlined the recommendations of the Subcommittee as follows:

- 1) Senator Sams be reprimanded by the Minnesota Senate.
- 2) Senator Sams be ordered to issue a public apology to the Minnesota Senate, his constituents, and the public.
- 3) Senator Sams be removed as a member and vice-chair of the Human Resources Finance Committee.

Senator Spear moved that the resolution relating to the conduct of Senator Dallas C. Sams (see resolution SRES-14-99) be recommended for introduction by the chair on behalf of the Committee on Rules and Administration. The **MOTION PREVAILED**.

The meeting adjourned at 11:50 a.m.

- BE IT RESOLVED, by the Committee on Rules and 4

- 6 Each member of the Senate who resides more than 50
- 7 miles from the state capitol shall be reimbursed for necessary
- 8 travel in going to and returning from the place of meeting to
- 9 the member's place of residence for each trip during the 81st
- Legislature. Mileage for travel by automobile must be at the 10
- rate of 32.5 cents per mile, or any greater or lesser amount 11
- 12 authorized by the Internal Revenue Service for employees.
- Mileage for travel by private aircraft must be at the rate of 55 13
- cents per mile. Commercial airfare must be the actual cost. 14
- Each member of the Senate shall be paid per diem living 15
- expenses for meals, incidental expenses, and lodging in an 16
- amount up to \$56 for each calendar day during the sessions of 17
- the 81st Legislature. 18
- 19 In addition to per diem living expenses, each member of
- the Senate who resides more than 50 miles from the state capitol 20
- shall be reimbursed up to \$800 per month for actual lodging 21
- expenses during the sessions of the 81st Legislature. The total 22
- reimbursement for those members, per diem plus lodging, may not 23
- exceed the amount per legislative day allowed by the Internal 24
- Revenue Service for an accountable plan. 25
- Each member of the Senate shall be reimbursed up to 26
- 27 \$100 per month for actual expenses for telecommunications.
- Each member of the Senate shall certify in writing to 28 5.
- 29 the Secretary of the Senate for the actual travel, living, and
- telecommunication expenses for which the member seeks 30
- reimbursement. 31
- 32 The Secretary of the Senate shall prepare and issue
- 33 warrants from the Senate legislative expense fund in payment of
