**Bachelor Complex**, Deschutes NF, USFS. CIMT (NW Team 3). IMT is also managing the Firestone and Flat Top fires. Twenty miles southwest of Bend, OR. Timber and closed timber litter. Moderate fire behavior with single tree torching, flanking and backing. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Firestone**, Deschutes NF, USFS. Twenty-one miles north of Fort Rock, OR. Grass, brush and timber. Active fire behavior with torching, flanking and backing. Residences, energy and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Flat Top**, Deschutes NF, USFS. Ten miles north of Fort Rock, OR. Grass, brush and timber. Active fire behavior flanking and backing. Numerous residences and energy infrastructure threatened.

**Rail Ridge**, Prineville, District, BLM. CIMT (CA Team 10). Fifty-one miles northwest of Burns, OR. Grass, brush and timber. Moderate fire behavior with smoldering, creeping and backing. Numerous structures, communication infrastructure and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

**Willamette Complex (4 fires)**, Willamette NF, USFS. CIMT (NW Team 2). Transfer of command from CIMT (CA Team 13) to CIMT (NR Team 6) will occur tomorrow. IMTs are also managing the Ore fire. Eight miles southeast of Oakridge, OR. Timber, brush and grass. Minimal fire behavior with creeping, backing and single tree torching. Area, road and trail closures in effect.

**Ore**, Willamette NF, USFS. Seven miles northeast of Blue River, OR. Closed timber litter and timber. Minimal fire behavior with creeping and smoldering. Structures threatened. Area, road and trail closures in effect.

**Red**, Deschutes NF, USFS. Eighteen miles west of Crescent, OR. Timber and closed timber litter. Minimal fire behavior with creeping, backing and single tree torching. Numerous structures threatened. Area, road and trail closures in effect.

**Wiley Flat**, Ochoco NF, USFS. CIMT (CA Team 1). Thirty-one miles southeast of Prineville, OR. Timber, brush and grass. Moderate fire behavior with backing, creeping and smoldering. Structures threatened. Area, road and trail closures in effect.

**Homestead Complex (4 fires)**, Umpqua NF, USFS. CIMT (NW Team 7). Thirty miles northeast of Glide, OR. Timber, closed timber litter and brush. Minimal fire behavior with backing, creeping and smoldering. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

**Diamond Complex (2 fires)**, Umpqua NF, USFS. CIMT (CA Team 14). IMT is also managing the Middle Fork fire. Eighteen miles southwest of Chemult, OR. Timber. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect.

**Middle Fork**, Crater Lake NP, NPS. Fourteen miles northeast of Union Creek, OR. Timber. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect.

**Shoe Fly**, Prineville Unit, ODF. Transfer of command from IMT 1 (ODF Team 1) back to the local unit will occur today. Forty-five miles northeast of Prineville, OR. Brush, grass and timber. Minimal fire behavior with creeping and smoldering.

**Whisky Creek**, Mt. Hood NF, USFS. Six miles southeast of Cascade Locks, OR. Timber, brush and closed timber litter. Minimal fire behavior with smoldering and creeping. Structures and energy infrastructure threatened. Area, road and trail closures in effect.

#### **Predictive Services Discussion:**

Ahead of an upper-level low moving south along the Oregon and California coast, near to above normal temperatures, breezy southwesterly sustained winds of 15-25 mph gusting to 40 mph amid minimum relative humidity of 10-25% will develop along the east slopes of the Sierra and much of the Great Basin. Scattered showers and isolated thunderstorms will develop across much of Oregon into northern California, spreading into the northern Great Basin overnight. Very warm and dry conditions are expected across much of the Front Range, Wyoming, and southeast Montana as well, although winds will be more from the south and lighter at 10-20 mph. Moisture will across much of Arizona into the Four Corners with scattered showers and thunderstorms. Farther east, southerly winds of 12-20 mph amid relative humidity of 15-25% and above normal temperatures are expected on the southern Plains.

In the East, remnant moisture from Francine will bring areas of wetting rain to the Lower Mississippi Valley. Well above normal temperatures and dry conditions will continue for much of the Midwest, central Appalachians, Mid-Atlantic, and Northeast. Downsloping easterly winds of 10-15 mph will continue in the Upper Ohio Valley, with minimum relative humidity in the teens creating locally elevated conditions. Lower relative humidity of 20-30% will also spread into much of the Lower Great Lakes. Strong, but moist easterly winds are expected along the Southeast coast due to a developing low pressure system.
