#### ERRATA

On February 10, 2011, the Administrative Review Board (ARB) issued its Final Decision and Order (F. D. &. O.) in this matter that came before the ARB pursuant to the statutory authority of the Davis-Bacon Act and its implementing regulations,<sup>1</sup> the United States Housing Act of 1937,<sup>2</sup> and the Contract Work Hours and Safety Standards Act.<sup>3</sup> The F. D. & O., however, contains numerical errors at pages 31 and 33.

At page 31, in the "Conclusion" paragraph, we correct the last two sentences to read, "However, we accept the Administrator's request and accordingly increase the ALJ's back wage awards to Patrick Richards, Clive Hall, Delroy Green, Edward Riley, Fabio Arbelaez, Philbert Franklin, Raymond Jesse Garcia, and Jude Merzy by a total amount of \$344,725.83. In sum, the total award is \$792,396.19."

At page 31, second paragraph of the "Order," we correct the award to Raymond Garcia, Jr. to read, "\$27,117.88."

At page 33, second paragraph, we correct the award to Manni Kavalos to read, "\$9,764.93."

At page 33, third paragraph, we correct the award to Delroy Green to read, "Delroy Green is awarded \$51,215.37. (The ALJ awarded \$9,709.13. This is an increase of \$41,506.24.)."

At page 33, we correct the last sentence to read, "The total amount of increase by ARB of the ALJ's amended award is \$344,725.83."

Additionally, at page 34, we correct the last name of Stanley "Petsagourakis."
