Promotion Purpose

To offer a chance to win a prize.

Promotion Period

The Promotion Period is from October 4, 2023 at 00:00:00 PDT and MST / 01:00:00 MDT and CST / 02:00:00 CDT and will expire on January 3, 2024 at 23:59:59 PDT / January 4, 2024 00:59:59 MST and CST / 01:59:59 CDT (the "Promotion Period").

Definitions

BCLC means British Columbia Lottery Corporation.
