
Appendix A. Data Sources

We used CDE TK enrollment data for the 2013-14 – 2019-20 school years. We focused on TK enrollment counted on census data (fall), rather than the cumulative count. Counts of kindergartners are also made on census day and include TK students. We subtract TK students from the kindergarten census day counts to come up with the counts of kindergartners. Enrollment data is available at the state, district, and school level by socioeconomic status, English Learner status, and for each racial and ethnic group.

Data on school and district enrollment, English Learner (EL) status, and student socio-demographic characteristics are also maintained by the CDE. Data on the "unduplicated" count of students, relevant for LCFF funding, are available at the school and district levels beginning in 2013, the first year of LCFF. School-by-grade enrollment, both overall and broken down by race/ethnicity/gender, as well as by EL status, is available going back to 1982. School and district-level free and reduced price lunch meal (FRPM) are available in the FRPM files.




FIGURE B2Most districts saw relatively little change in TK take up rates with declining enrollment adjustment


FIGURE B3 Excluding LAUSD lowers the overall take up rate from 21% to 19%





FIGURE B5Among Filipino and Pacific Islander students, Dual Language Learners have lower take-up rates than Non-Dual Language Learners






FIGURE B7Some districts serve many more students than are strictly eligible based on birthdates




FIGURE B9Take up rates for FRPM eligible students somewhat lower in rural districts

FIGURE B10 Eligible rural DLL children not enrolled in TK



If a school serving kindergarteners is serving fewer than 25% of the size of their kindergarten class in TK, we count that difference as eligible TK students. Because some districts provide Extended TK or other TK programs that allow younger birthdates to qualify for TK participation, our estimates may undercount students not enrolled in schools providing TK. All schools serving K students, including charters, are included. There are 500 eligible but unserved rural DLL children.
