## Public Comment Hearings Set for Columbia Gas STRIDE Proposal

(BALTIMORE, MD) – The Maryland Public Service Commission has scheduled two public comment hearings on the gas infrastructure enhancement plan filed by Columbia Gas of Maryland. Columbia Gas provides natural gas distribution services to 34,000 customers in the western Maryland counties of Allegany, Garrett and Washington.

Columbia Gas, a subsidiary of NiSource, Inc., has filed for approval of its 2024-2028 Strategic Infrastructure Development and Enhancement (STRIDE) plan and an associated surcharge. Columbia's investment plan accelerates cost recovery of eligible gas system infrastructure replacements and is estimated to range from \$17 million to \$22.4 million a year to be collected over a five-year period beginning January 1, 2024. As proposed, the estimated monthly surcharge under Columbia's STRIDE Plan would be \$2.00 for a residential customer.

The utility's customers and other interested parties are welcome to attend and provide comments. Public Utility Law Judge Christine L. Burke will preside over the hearings scheduled as follows:
