3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Investing in Main
5 Street Act of 2021”.

1 **SEC. 2. INVESTMENT IN SMALL BUSINESS INVESTMENT**
2 **COMPANIES.**

3 Section 302(b) of the Small Business Investment Act
4 of 1958 (15 U.S.C. 682(b)) is amended—

5 (1) in paragraph (1), by inserting before the pe-
6 riod at the end the following: “or, subject to the ap-
7 proval of the appropriate Federal banking agency,
8 15 percent of such capital and surplus”;

9 (2) in paragraph (2), by inserting before the pe-
10 riod at the end the following: “or, subject to the ap-
11 proval of the appropriate Federal banking agency,
12 15 percent of such capital and surplus”; and

13 (3) by adding at the end the following:

14 “(3) APPROPRIATE FEDERAL BANKING AGENCY
15 DEFINED.—In this subsection, the term ‘appropriate
16 Federal banking agency’ has the meaning given the
17 term in section 3 of the Federal Deposit Insurance
18 Act (12 U.S.C. 1813).”.
