



## 10 KEY STEPS TO STARTING A BUSINESS

*For Businesses Within the City of San Diego Limits*

So you want to start a business in the City of San Diego? Here are the key steps, which may vary depending on your type of business. Following 10 Key Steps will give you the general idea and help the process go smoothly.

*Many steps can be researched and processed online through the websites listed, saving you the time of calling or visiting department or agency offices. The City's Central Library and all branches provide Internet access during library hours.*

### 1. Research the Basics and Visit the OpenCounter™ Portal

The City of San Diego's Economic Development Department acts as an information clearinghouse for City business programs and services. It serves as your resource partner, connecting you with a variety of business assistance agencies. The department coordinates with City staff to provide the Business Tax Certificate (business license) and zoning, permit and regulatory information to businesses--big, small and startup.

- ◆ Check out the City's award-winning **OpenCounter Online Business Portal** ([business.sandiego.gov](https://business.sandiego.gov)). This free, one-stop, online portal provides guides you through the startup process. Save time. Find permitted locations for your business (before signing a lease). Determine which permits you'll need and how much they'll cost so you can better plan your business. (Use OpenCounter for residential home improvements, too!)

## 2. Create Your Business Plan

A **Business Plan** will be your roadmap. It'll show you where you are in relation to where you want to be. Your Business Plan will help you outline and document the actions you need to take. Many businesses fail without a solid Business Plan. One more thing: Banks require you to have a Business Plan to be eligible to apply for a loan.

The San Diego **Small Business Development Centers (SBDC)** offer technical assistance to aspiring entrepreneurs and small businesses in San Diego County. ## 3. Determine Your Business Name

The name you choose for your business is very important. If it's your own legal last name (surname) and a one-word description (such as "John Smith Roofing"), then you are not required to register a fictitious business name. If you have a business outside these parameters (such as JS Expert Roofing) *and* your business is not registered with the State, State law requires you to file a **fictitious business name statement (FBN)** with the County of San Diego. This statement, however, does not protect the business name.

## 4. Determine the Legal Structure for Your Business

Your choice of legal structure will affect your income taxes and personal liability. Several legal structures exist in the State of California. Most businesses start as a **Sole Proprietorship** or a **General Partnership**, which are generally the least complicated. **Limited Partnerships, Limited Liability Partnerships, Corporations** and **Limited Liability Companies** must register with the California Secretary of State. You are strongly advised to contact your own accountant or attorney for advice about which is the best legal structure for you and your business.

## 5. Select Your Business Activity Type

In San Diego, there's a business activity classification system that identifies a business activity and determines a business's start-up requirements and where it can be located. Here's a list of common **Business Activity** types, which can also be found on the Business Tax Certificate (business license) application.

## 6. Select Location and Determine Zoning and Site Permit Needs

Before you sign a lease or purchase a property, you should first check to see whether you're allowed to use the space for your type of business, which permits are required and what they'll cost. The City's **OpenCounter Online Zoning Portal** and **Business Portal** can help.

- ◆ Not sure where to locate? Submit an inquiry through the City's **OpenCounter Online Business Portal** to obtain information regarding permitted locations, site permit requirements and get fee estimates. This will give you the information you need and help you know the types and costs of permits you might need before locating, opening or expanding your business.

## 7. Get Special Licenses and Permits

Your Business Activity type determines which licenses and permits are needed to operate a business legally. The City's **OpenCounter Online Business Portal** ([business.sandiego.gov](http://business.sandiego.gov)) provides plenty information. Here are some key contacts:

- ◆ The **CalGOLD Business Permit System** (database) assists you in finding appropriate permit information for your business. It also provides contact information for the various agencies that administer and issue these permits. CalGOLD issues neither permits nor licenses and does not provide information on any specific license number(s). If you have questions, contact the agencies that serve your Business Activity type.

- ◆ Certain types of Business Activities are regulated by the **San Diego Police Department** (SDPD) and require a Police Permit. The City of San Diego's **Police Regulated Permitting Application** process is administered by the Office of the City Treasurer. Regulation and enforcement is performed by SDPD. - ◆ Businesses that sell **goods by weight or volume** must register the devices with the **County of San Diego Agriculture, Weights and Measures** office. Permits are usually required for businesses that import/export businesses, engage in **agricultural-related production** or use **pesticides**.

- ◆ On the **Federal** level, employers must register as an employer with the Internal Revenue Service (IRS) to obtain a **Federal Employer Identification Number** (EIN). Employers must also pay additional taxes; withhold, match and submit employee withholdings; obtain worker's compensation insurance and adhere to employee eligibility regulations. The EIN is a nine-digit number that the IRS assigns to business entities and uses to identify taxpayers that are required to file various business tax returns. EINs are used by employers, sole proprietors, corporations, partnerships, nonprofits, trusts and estates, government agencies, certain individuals and other business entities. EINs can be obtained by completing form SS-4 online or by calling the IRS.

## 10. Apply for a Business Tax Certificate (Business License)

Any person or entity doing business in the City of San Diego for **more than six days** in one calendar year must have a **Business Tax Certificate**. Home-based businesses (Home Occupation), self-employed persons and independent contractors are also required to have a Business Tax Certificate. You can apply for a Business Tax Certificate online or in person.
