Be it resolved by the people of the state of Missouri that the Constitution be amended:

Article X is amended by adding one new section to be known as Section 27, to read as follows:

Section 27. After the effective date of this section, the state, counties, and all other political subdivisions are hereby prohibited from imposing or collecting any tax on personal property other than sales tax which may be collected each time the property is purchased.
