BE IT RESOLVED BY THE PEOPLE of the state of Missouri that the Constitution be amended:

Article V entitled Judicial Department, is amended by adding one new section to be known as Section 32, to read as follows:

The Supreme Court allows certified paralegals or legal assistants certified by a credited college or university to shadow and work alongside of an attorney at law for a period of three years. Thereafter, the person would be allowed to take a bar exam and if passed will be able to practice law in Missouri and will be accepted by the Supreme Court and the Appeals Courts and all Courts and Tribunals in the state and have the same basic rights to practice law and give legal advice to the People of the state.
