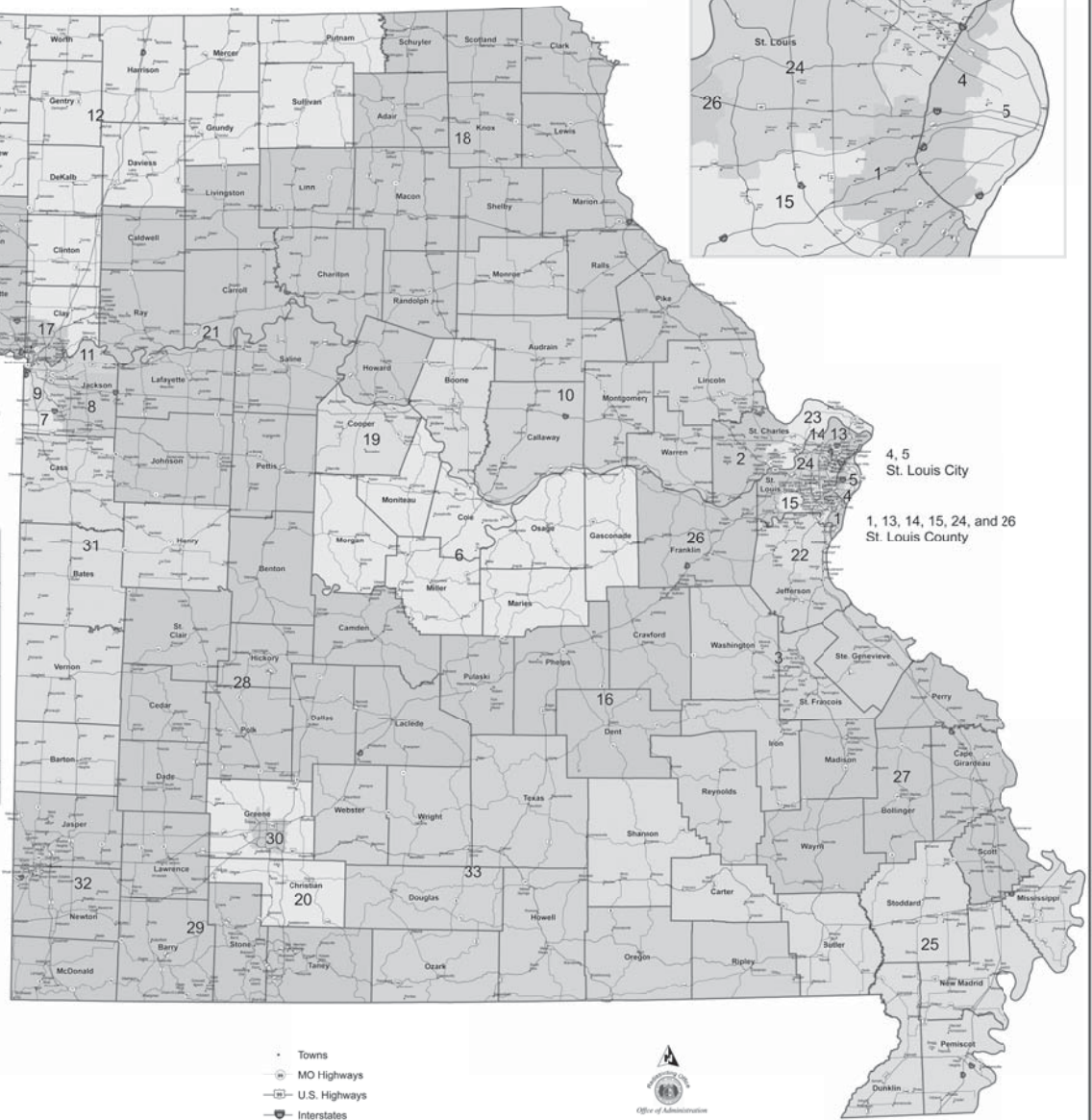

STATE REPRESENTATIVE DISTRICTS

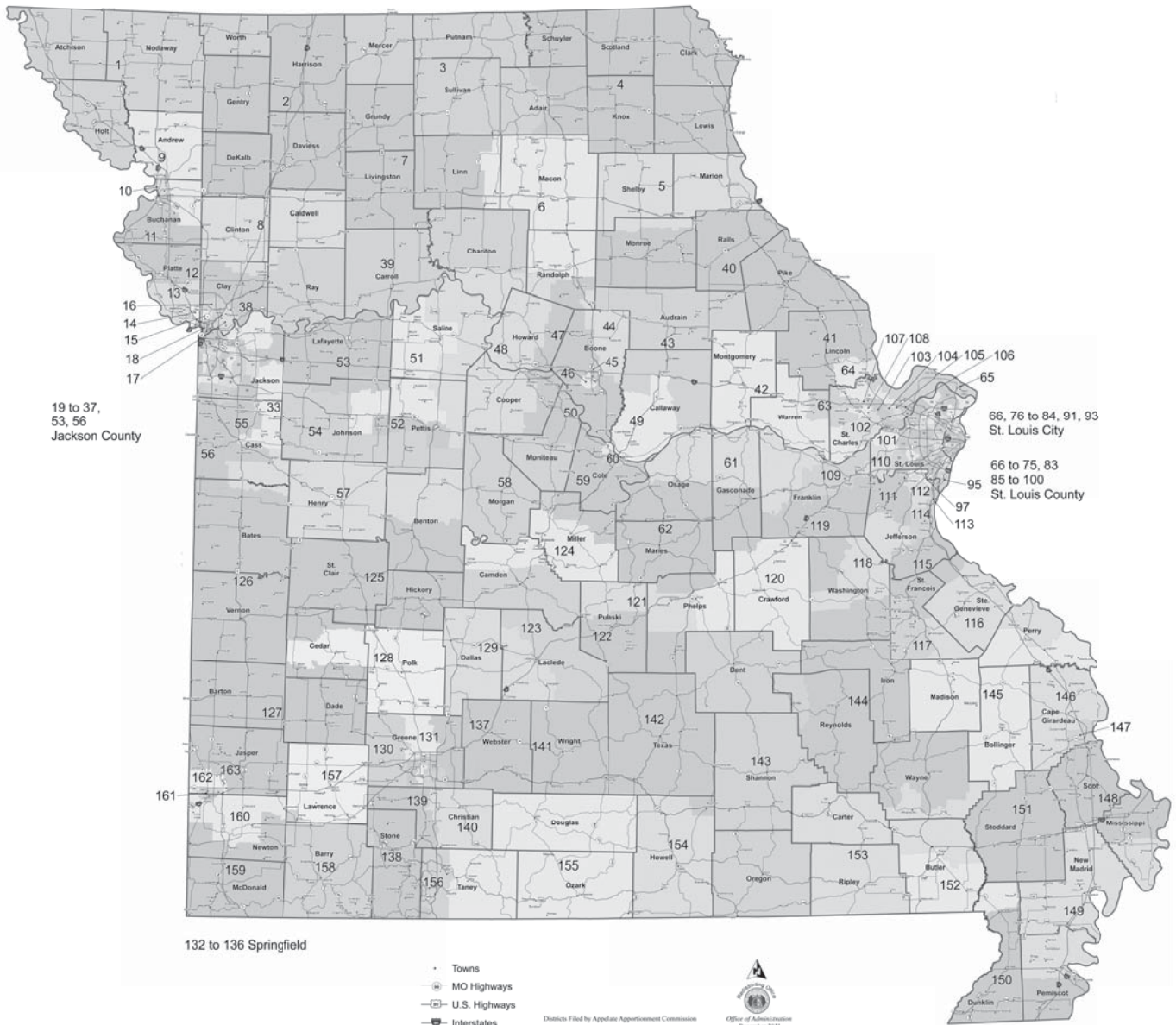
