20th Avenue South Street Vacation Public Engagement Summary

Overview

As part of voter-approved regional light rail expansion, Sound Transit needs to build a new Operations and Maintenance Facility (OMF) in the South Sound to accommodate additional vehicles for the future 116-mile system. We launched the OMF South project in 2018 with the Tacoma Dome Link Extension. After multiple rounds of engagement, the Sound Transit Board identified a set of alternatives to carry into environmental review in 2019.

We published a Draft Environmental Impact Statement (EIS) under the State Environmental Policy Act (SEPA) in 2021 that evaluated three possible sites for the OMF South facility: the Midway Landfill Alternative, the South 336th Street Alternative, and the South 344th Street Alternative. After consideration of the Draft EIS analysis and comments received from the public, the Sound Transit Board identified the South 336th Street Alternative as the preferred alternative. To align federal and state processes, we published a National Environmental Policy Act (NEPA) Draft/SEPA Supplemental Draft EIS on Sept. 22, 2023, evaluating the alternatives studied in the 2021 SEPA Draft EIS. Sound Transit and the Federal Transit Administration published the Final EIS on June 7, 2024. On June 27, 2024, the Sound Transit Board selected the preferred alternative (South 336th Street Site) as the project to be built.

Engagement by the numbers

In March 2024, the project team initiated an engagement period to collect and understand community input around proposed street changes and associated public benefits for the preferred alternative site. Sound Transit is preparing a street vacation application for the City of Federal Way to make street changes associated with the site. A street vacation is the permanent closure of a roadway.

The preferred alternative design involves closing 20th Avenue South from South 336th Street to South 341st Place. It would also extend 18th Place South from South 340th Street to South 336th Street to replace the closing street and extend 21st Avenue South from South 344th Street to South 341st Place to avoid a dead-end street for emergency vehicles. In addition to these street changes, we're proposing potential public benefits, including a multi-use path along the 18th Place South extension for people walking, rolling, and biking, and public space along South 336th Street at the northern edge of the facility, with amenities like seating, landscaping, artwork, or educational signage (see appendices A-C for more information).

Public feedback opportunities

From March 11 to March 31, the public provided feedback in the following ways:

- Submitting feedback through the online survey form on our website.
- Attending one of two drop-in sessions:
 - o March 16, 11 a.m. to 1 p.m., Federal Way Library
 - o March 26, 5 p.m. to 7 p.m., Federal Way 320th Library

Summary of survey feedback

The engagement period included a 14-question survey concerning the respondents' experience in the area and proposed public benefits, with six optional demographic questions. There were 94 survey responses recorded, which can be found in Appendix F with the survey questions.

Your experience in the area

- Most people are local and have used this section of 20th Avenue South before.
 - 53.2% of respondents (50 people) lived or owned a business within a half-mile of the preferred alternative site.
 - 68.1% of respondents (64 people) say they have walked, rolled, biked, or driven on the portion of 20th Avenue South that will be potentially vacated.
- Of those who have travelled on 20th Avenue South:
 - Most respondent drive to get to local destinations (79.7%, 47 people).
 - Many respondents drive on 20th Avenue South to avoid traffic in the area (52.5%, 31 people).
 - o A further 20.3% of respondents (12 people) walk.
 - o Another 6.8% of respondents (four people) bike or roll.

Respondents had the option of selecting multiple answers.

Potential changes to the street network

- When asked to comment on the proposal to close 20th Avenue South and extend 18th Place South, 37 respondents provided additional remarks.
 - Eleven comments (29.7%) were positive, noting their intended use of the multi-use path approval of general bike and pedestrian improvements, while the rest were not in favor of the preferred alternative.
 - Comments included a need for a traffic light at the intersection of South 336th Street and the extended 18th Place South, concerns about increased congestion in the area, and concerns about residential and business displacements from the OMF South project.
 - Others noted a concern for the safety of children and community members using the area for recreation due to potential traffic impacts and impacts to wetlands if the preferred alternative is selected. Commenters also expressed safety concerns regarding additional cars using the existing 18th Place South between South 341st Place and South 344th Street as a cut through route to avoid traffic.
 - Several respondents expressed concern about access to the South King Tool Library on South 340th Street. The property housing the tool library would not be affected by the street changes, and the 18th Place South extension would provide another path to the community resource.

Proposed public benefits

- When asked if they were excited about the proposed multi-use path along the extended 18th Place South, 40.7% of respondents (37 people) were not sure or had no opinion, 30.8% of respondents (28 people) said they were excited, and 28.6% of respondents (26 people) noted that they have concerns.
 - Forty of the respondents commented, noting concerns about unhoused community members using the area as an encampment. Several commenters expressed support for pedestrian and bike improvements in the area.
- When asked if they were excited about the proposed public space along South 336th Street, 34.4% of respondents were not sure or had no opinion (31 people), 34.4% of respondents noted that they had concerns (31 people), and 31.1% of respondents (28 people) said they were excited.
 - Fifty of the respondents commented, noting similar concerns raised in the previous openresponse question. Some noted their excitement for an overlook area on train operations, with one noting that it would be especially nice for children excited about transit and trains.
- Of the features or amenities proposed in the design of the **public space** along South 336th Street, 70% of respondents (56 people) would like increased pedestrian lighting, and 58.8% (47 people) would like an overlook to the train yard of the OMF. Additionally, 48.8% of respondents (39 people) would like benches or other seating. Please note that respondents can select multiple answers.
- When prompted to provide feedback on the theme of the public space, responses were mixed. Some respondents reacted positively, sharing they thought transportation was an "excellent theme" and that it "makes sense to tie in topics with a transit focus." Several commenters expressed dislike of the theme and commented against Sound Transit's proposal for an OMF in the area. Several comments expressed ideas for other themes or topics to cover within the transportation theme, such as information about early road networks, horsedrawn wagons, and logging history. Ideas for other themes included a focus on nature, as well as the history of the Indigenous people of the area.
- When prompted to provide feedback on other aspects of the City of Federal Way that the project team should draw inspiration from, respondents commented that they would like the project team to look towards the many lakes and water views in the area, local flora and fauna, local Indigenous design, local wildlife, and the diversity of Federal Way.
- When prompted to provide any additional comments about the potential street vacation or suggestions for potential public benefits to share with Sound Transit or the City of Federal Way, multiple comments expressed concerns for safety in the area. One respondent commented that it would be "great to have more walking and biking traffic through the area," which was affirmed in other comments. Additionally, a respondent commented, "having the train yard be viewable from the footpath would be a major boon towards public transparency and visibility."

Demographics

The survey included six optional demographic questions with 63.5% of respondents (54 people) opting to answer them. Most respondents who answered the optional demographic questions identified as above 50 years old, white, and reported a total household income above \$50,000. A full review of the responses to the demographic questions can be found in Appendix F.

Outcomes and next steps

We have shared this summary of feedback with the City of Federal Way. On June 27, 2024, the Sound Transit Board selected the preferred alternative (South 336th Street Site) as the project to be built. Sound Transit is preparing a street vacation application for the City of Federal Way and anticipates submitting the application in the third quarter of 2024.






Appendix A: Existing Conditions Map












