## 2024 RENEWAL MEMBERSHIP PACKAGES AND DETAILS

### MEMBER EVENTS

StoneWater Golf Club offers many events for Men, Women and Couples.

A full schedule of Men's events include:

- Opening and Closing Day; a 3-Day Member Invitational (see details below); Member Stag Days; Member Guest Days, Evening Leagues, and Holiday Tournaments.

The StoneWater Women's Golf Association offers numerous golf events which include:

- Opening and Closing Day; 9- and 18-hole programs; Interclub matches; Member Guest Days; Holiday Tournaments, Happy Hour Tournaments; and GCGA Events.

Couple's events are held throughout the season with a mix of member and guest events played using various formats. Couple's events can be twilight or daytime events; be structured around special dinners prepared by our chefs; and can include social events like wine, craft beer or special liquor tastings.

### THE 2024 MEN'S 3-DAY INVITATIONAL

The Invitational Committee which includes Richard Adler, John Anderson, Bernie Beaudoin, Denny Delbane, Dave Koski, Hugh Morgan, Rich Ranells, Jim Sciortino, and Tom Smith has changed the determination of those who play in what is undoubtedly the flagship, premier event of the year. The 2023 event, like past years competes with a full field of 60 and a waitlist which was limited to 30 potential players. With a large waitlist and many others who have asked to play in the event, for the 2023 event the Invitational Committee changed the selection process resulting in 11, 1<sup>st</sup> time players in the event.

During the early membership renewal process, we will reach out to you to determine your interest in playing in the 2024 Invitational. Thus, those members who have rejoined by the October 15 early renewal deadline will be given priority in the selection process with unlimited members being weighted ahead of 15 round members. The details on the selection process will be sent shortly in a separate communication.

### LINKSMAN GOLF ACADEMY & GOLF PROGRAMMING FOR MEN, WOMEN & STUDENTS

As you know, a significant investment was made in the Linksman facility this past year to enable it to be used year around. We are developing those details to allow members to use the facility throughout the winter months to continue to swing their clubs; to play numerous courses throughout the world via our simulators either individually or via leagues; and of course, to continue to take lessons and fittings with our pros.

During the season, under the guidance of our pros, our Linksman Golf Academy is a great way to perfect your swing and try out the newest equipment while having your swing analyzed using the latest GPS Trackman technology. Our demo days also enable you to talk directly with the representatives of each manufacturer to hear firsthand about what's coming in the latest equipment.

There are also numerous clinics for all ages including students taught by our Player Development pro Joe Meglen, the master instructor Bob Bourne and the Head Golf Pro Bryan Huff.

## PRACTICE AND TEACHING AREA

With unlimited use and nearly a 35,000 sq./ft. practice area, you will always have something to work on. The range has five bent grass, target greens, as well as three private areas for the StoneWater PGA Teaching Professionals. There is also a spacious practice putting green, a large chipping green, and a fairway bunker practice area. Subject to inclement weather and normal maintenance, the range, practice bunkers, and putting and chipping greens for short game practice are available all season.

## 14-DAY ADVANCED TEE TIMES

Members have the ability to book starting times up to 2 weeks prior to when they want to play which is a full week ahead of any non-member bookings.

## EXCLUSIVE MEMBER TEE TIMES

“Peak Times” are defined as Fridays from 11am-3pm; Saturday-Sunday before 11am; and on holidays before 11 am. These times are reserved exclusively for our members and guests playing with members.

## RECIPROCAL ARRANGEMENTS WITH LITTLE MOUNTAIN COUNTRY CLUB

Members are invited to play at Little Mountain and can book tee times through the StoneWater Golf Shop. Rounds member accounts will be reduced for the appropriate points for green fees. StoneWater points cannot be used for any guests StoneWater members bring to Little Mountain. Thus, all guests of StoneWater members would pay the Little Mountain rates for the time/day of week. All members including those with a StoneWater membership that includes a prepaid cart, will be charged full cart fees at the then current Little Mountain rate. Tee times can be booked two weeks in advance for all times other than Saturday and Sunday and Monday holidays before 11:00 am. Those times are reserved for Little Mountain players and are subject to availability one week in advance. Little Mountain cart rates can be obtained through the StoneWater Golf Shop.

The table below shows the rates that will be charged to StoneWater members under various circumstances. The rates will vary based on the time of day and day of week.

All guests of StoneWater members would pay the Little Mountain guest fees for the time/day of week. Little Mountain rates can be obtained through the StoneWater Pro Shop.

Programs can include all of the golf amenities of StoneWater; specially designed group clinics; contests and events; Golf Shop assisted pairings and tee times; and various food and beverage packages.

### USGA GHIN HANDICAP

All memberships include a USGA GHIN Handicap and inclusion on all related offerings and newsletters.

### GOLF SHOP DISCOUNTS & PERKS

Members receive 10% discounts on Golf Shop apparel and merchandise excluding clubs. Golf clubs are competitively priced and can be purchased with a fitting from one of our Golf Professionals.

### MEMBER ONLY WEBSITE PORTAL

A portal for members only to book tee times, receive advance information on StoneWater happenings and other member benefits.

### MEMBER SERVICES & AMENITIES

StoneWater Golf Club member's services include men's and women's locker rooms; bag storage; GHIN Handicap Service; member charging privileges; and, the ability to ship golf clubs to your travel destinations.

### A REFERRAL FOR OUR EXISTING MEMBERS

We will launch our 2024 early new membership program shortly. We have an incentive being offered only to our existing members. You will earn 3 guest passes for 2023/2024 and a Rustic Grill gift card equal to 5% of the value of an unlimited member you refer to StoneWater and a Rustic Grill gift card equal to 10% of the value of a 15 round membership purchased. And remember, new members who join now can play the rest of 2023 for only a cart fee and can use the Linksman House during the winter months.

### STONEWATER HOLE-IN-ONE FUND

StoneWater has established a \$5 hole-in-one fund available only to Members. Should a Member have a hole-in-one properly witnessed by a second person, the Member will be awarded the balance in the fund in StoneWater credits to be used in the Pro Shop or the Rustic Grill. Each time a Member has a hole-in-one, the fund will be replenished by a \$5 charge to each Members' account. Participation in the fund is extended to all Members and is not optional. Family and Corporate memberships will be charged \$5 for each individual member as each is eligible to participate. At the end of the season, the fund balance will carry over to the next year and any new members will be charged the \$5 fee at the time they join.

### AGE RELATED MEMBERSHIPS

Age related memberships are based on the member's age as of January 1, 2024.

### 15 ROUND PACKAGE MEMBERS

15 Round members that upgrade to an unlimited membership can play the rest of 2023 for only a cart fee. Rounds are tracked in 9-Hole increments using a point system. Thus, a 15 round package is 30 points. Rounds expire on December 31, 2024, and cannot be transferred to future years. During Peak Times rounds can only be used by the Member and can be used for guests outside of these restricted times. Guests during Peak Times pay the regular Member guest green and cart fees.

### OTHER MATTERS

- All Rounds Package and Unlimited are considered "Members" and to the extent available may participate in all Members Events and Leagues.
- "Peak Times" are defined as Fridays from 11am-3pm; Saturday-Sunday before 11am; and on holidays that fall on a Monday before 11am.
- Public play is permitted during non-peak times. Public tee times, however, can only be made one week in advance.
- Sales tax and admissions taxes will be added to all charges where required.
- The season runs for the calendar year 2024 with the course generally closed depending on weather from November 1 until sometime in March.
- Play on the course may be restricted at times due to inclement weather; during normal course maintenance; or during member events or outings.
- A Member Handbook is in the Member portal on the website that contains details on all of the StoneWater club policies, rules and regulations and contact information.

### PAYMENT PLAN FOR THOSE SELECTING THE WIE, KOEPKA OR SPIETH PACKAGE

Those under age 36 selecting one of these three packages can elect to pay 25% at the time of joining with the balance paid ratably each month such that the last payment is August 2024. For example, join under the Koepka Package before December 31; pay \$600; and pay the balance of \$1,800 over 8 months beginning on January 1 at \$225 per month. All monthly billings will be charged on the 1<sup>st</sup> of the month to the Members credit card.
