## REQUEST FOR CRIMINAL HISTORY EVALUATION LETTER INSTRUCTIONS

If you are also submitting an application, do not fill out or submit this form. This form is not part of the application process.

## YOUR REQUEST WILL NOT BE PROCESSED UNTIL ALL ITEMS HAVE BEEN SUBMITTED.

The request form must be completed and signed by the person requesting the evaluation letter.

If you are seeking a determination of your eligibility for more than one license type you must submit a separate request and application fee for each license type. You do not have to submit a separate request for each crime.

- 1. <u>NAME</u> Please provide your name in the space provided. (Last Name, First Name, Middle Initial) Examples of a suffix include Jr., Sr., and III. (Mr. is not a suffix)
- 2. <u>DATE OF BIRTH</u> Provide the two-digit numeric equivalent (ex: 03 for March ) for the month of your birth, followed by the two-digit day and four-digit year. (MM/DD/YYYY)
- 3. GENDER Check "M" for Male or "F" for Female.
- SOCIAL SECURITY NUMBER The Social Security Number disclosure is required by Section 231.302(1) of the Texas Family Code to obtain a license. Your social security number is subject to disclosure to an agency authorized to assist in the collection of child support payments. For more information regarding child support payments, contact the <u>Texas Attorney General</u> or call (512) 460-6000 or (800) 252-8014.
- 5. <u>MAILING ADDRESS</u> This is the address to which the Department will mail your correspondence. Indicate the number and street, or post office box of your mailing address. The use of the zip plus-4 is not required, but it helps the postal service direct mail more efficiently and accurately.
- 6. <u>TELEPHONE NUMBER</u> Provide the telephone number, including area code, where we can reach you during the day. This may be your office phone number where we can leave a message.
- 7. <u>FAX NUMBER</u> List any fax number where you will be able to receive documents from the Department. Leave this blank if you do not have access to a fax machine.
- 8. <u>EMAIL ADDRESS</u> Please provide your email address. Your email address is confidential pursuant to the Texas Public Information Act, and the Department will not share it with the public.
- 9. <u>ALL NAMES BY WHICH YOU HAVE BEEN KNOWN</u> List any name you have ever used. This would include a maiden name, nickname, alias, etc.
- 10. <u>LICENSE YOU WILL BE SEEKING</u> You must check the box for the license type you are requesting a criminal evaluation letter for. If you plan to apply for more than one license, a separate request and application fee must be submitted for each license you will be seeking.
- 11. <u>SIGNATURE</u> Carefully read the statement oat the bottom of the request form before you sign and date the form. Be aware that the information provided on this request form, and any attachments, will be investigated. Providing false information may result in denial or revocation of any future license and the imposition of administrative penalties.

- 1. <u>TYPE OF REQUEST</u> Check the box to indicate whether you are applying for a new license or renewing a license.
- 2. <u>TYPE OF LICENSE</u> Provide the type of license you are applying for or renewing. (ex: Barber, Cosmetology, Electrician, Towing, Air Conditioning Technician, etc.)
- 3. <u>NAME</u> Write your full legal name in the spaces provided. (Last, First, Middle Name)
- 4. <u>SOCIAL SECURITY NUMBER (SSN)</u> Social Security number disclosure is required by Section 231.302(1) of the Texas Family Code in order to obtain a license. Your social security number is subject to disclosure to an agency authorized to assist in the collection of child support payments.
