AI Principles At TEKsystems Global Services

BE FAIR	Models and AI systems should be impartial and free from bias. AI data sets and algorithms should be able to be evaluated and deeply investigated to root out the source of potential bias. AI systems should perform reliably and as expected.
BE ACCOUNTABLE	People must oversee the application and development of AI and take responsibility for the functioning of AI systems. Humans must incorporate reporting and feedback mechanisms into AI systems that enable customers to flag problems.
BE TRANSPARENT	AI systems should provide meaningful information. People must be able to freely disclose the types of data used in an AI algorithm and be able to explain decisions.
BE ETHICAL	Data protection, privacy and intellectual property laws must be respected, meeting industry best practices to protect customer data during its collection, storage and use. Throughout their life cycle, AI systems must be resilient, secure and safe.
