Summary:

The Tunica-Biloxi Economic Development Corporation is seeking a highly organized and experienced Dry-Cleaning and Laundry Manager to oversee our daily operations and ensure the smooth functioning of our business. The Manager will be responsible for managing daily operations, coordinating production schedules, and maintaining quality control standards. The ideal candidate will possess strong leadership and customer service skills, and have a keen eye for detail. This is a working manager position that will require active engagement alongside dry cleaning and laundry production team members as needed to meet company goals and objectives.

Principle Duties and Responsibilities:

- Provide exceptional customer and employee service in highly structured environment focused on enhancing and building customer relation.
- Oversee all aspects of dry-cleaning and laundry operations, including production, inventory management, quality control, and customer complaints.
- Have a strong understanding of commercial dry cleaning and laundry operations and equipment.
- Ensure quality and production standards are met through spotting, pressing, finishing, and assembly of garments.
- Set goals and measurable objectives for the business to measure success and establish accountability standards.
- Train, supervise, and evaluate staff to ensure high performance and productivity.
- Oversee and facilitate equipment training and ensuring all team members meet standards for safety.
- Implement and enforce safety protocols to ensure a safe working environment for employees.
- Meet deadlines and complete job tasks as set by leadership without direct monitoring or oversight.
- Supervise the timely pickup, cleaning, pressing, and delivery of guest clothing and linen to meet business goals and objectives.
- Ensures policies are administered fairly and consistently, disciplinary procedures and documentation are completed according operating procedures.
- Plan, organize, and prioritize work activities to meet turnaround time requirements.
- Provide staff with assistance in performing difficult or complicated duties.
