 In 2020 UNCCT 5-Year Programme coming to an end, and KPMG was contracted to undertake an evaluation of the Programme:

"to produce for the Office of Counter-Terrorism a strategic forward-looking evaluation report that will evaluate the current status and performance of UNCCT, including by undertaking an assessment of the progress made towards the attainment of the UNCCT 5-Year Programme outcomes in a balanced manner, and provide information that will guide future orientation of capacity building, and for the UNCCT's further development as a Centre of Excellence"



Evaluation Process

Evaluation process was impacted by COVID 19

Online interviews with stakeholders from the countries in scope – due to travel restrictions

In-depth study of 23 projects from three countries (Indonesia, Nigeria and Pakistan) and one region (Central Asia)

Interviewed 110 interviewees, including 18 Advisory Board Members

Conducted an electronic survey of Counter-Terrorism Compact entities



Key Findings

- 1. UNCCT has benefited from the transfer to UNOCT through **enhanced access to political and diplomatic support**, and access to **support services**
- 2. UNOCT has enabled UNCCT's **deeper integration into the United Nations'** counter-terrorism architecture
- 3. Strategic and programme governance, monitoring and evaluation, as well as information management identified as key areas for improvement
- 4. UNCCT has not yet achieved 'Excellence'



Key Findings (cont.)

5. Assessment against **OECD/UNEG Criteria** of Effectiveness, Efficiency, Relevance, Coherence and Sustainability:

- **Effectiveness** of the 5-Year Programme could not be determined, but the trend is positive
- Efficiency of the 5-Year Programme is satisfactory, focusing on the period since 2017
- **Relevance** of the 5-Year Programme to the United Nations' Global Counter Terrorism Strategy was found to be satisfactory
- Internal coherence of UNOCT was diminished by maintaining two capacitybuilding units, i.e. SPIB and UNCCT
- **Sustainability** of the 5-Year Programme could not be determined due to in part, the lack of evidence on the outputs and outcomes achieved



Key Recommendations

Based on the findings, KPMG has made **16 recommendations**, including:

- R.2: Convened by the UNCCT Advisory Board Chair, board members and UNCCT/UNOCT Senior Management should arrive at a position that enables the outcome monitoring of UNCCT programmes.
- R. 8: The next programme cycle to be oriented around **a six-year strategic plan**, subject to a biennial review and **synchronized with UNGCTS** biennial review
- R: 14: Consolidate into a single capacity development unit within UNOCT by integrating the Special Projects and Innovation Branch into UNCCT
- R. 15: Recommendations aimed at instilling 'a results-oriented culture':
 - improving **monitoring and evaluation**
 - $\circ~$ re-organising M&E function: evaluation to be moved to the OUSG and monitoring to PMU
 - o improving strategic guidance in programme design



- Management Response

- Report provides useful suggestions that will support UNCCT's development as a Centre of Excellence in tandem with the recommended "culture of excellence"
- UNOCT has agreed to all recommendations in principle
- Some recommendations will require more information and time before implementation
- Comprehensive management responses have been prepared in response to the recommendations
- UNOCT is developing an **Action Plan** for the implementation of the management response






Geographical Scope & Distribution by Pillar

- Continue enhancing the Center's visibility








In Q2 and Q3 of 2020 UNCCT has delivered:

- Expenditures and Utilization Rates

As of 30 September 2020:

- Utilization against the released budget of US\$29 million is US\$13.3 million or 46% of the total released budget
- The utilization rate is down 4% compared to Q3 2019






