

#### Overview of sociodemographic trends in LAC



- Prolonged and aggravated social crisis (25-year setback in poverty). Incidence of poverty is greater among children, adolescents and young people; women; indigenous peoples;
   Afrodescendant populations
- Rapid population ageing: population aged 60 years and over will increase from 13.8% of the total population in 2023 to 25.1% in 2050
- Life expectancy: upward trend despite temporary setback due to COVID-19 pandemic: loss of
   2.9 years between 2019 and 2021
- Below-replacement fertility since 2015. Adolescent fertility remains very high: LAC has some of the highest birth rate for adolescents aged 15–19 (51.4 children per 1,000 adolescents in 2023)
- Intraregional migration: largest relative increase in the world between 2000 and 2020 (72%):
   6.1 million migrants and refugees from Venezuela in LAC countries



#### Key population and development challenges in LAC



- Significant vulnerabilities of children, adolescents, and young people
- Need for universal social protection systems (pensions, health and care services), especially important for older persons
- Setback in economic autonomy of women; poverty; excess burden of care work; persistence of gender-based violence
- Vulnerability of migrants, particularly women and unaccompanied children
- Lack of protection of territorial rights of indigenous peoples
- Need to eliminate racism and the multiple forms of discrimination against Afrodescendant persons
- Need to guarantee visibility and non-discrimination of population with disabilities


