## **Background and Rationale**

In many conflict-affected countries the scale of displacement is so significant and the percentage of the population displaced is so high that finding durable solutions for internally displaced people is a critical element of sustainable and effective peacebuilding. In total, some 25 million internally displaced persons (IDPs) reside in countries afflicted by or recovering from protracted violent conflict. Durable solutions can be achieved through their return to the place - and reintegration at the place - of origin, as well as local (re)integration in the areas in which IDPs originally take refuge or settle in another part of the country.

The return of internally displaced persons to their places of origin is often the preferred option for IDPs. Return and reintegration of displaced people are used as an indicator of effective peacebuilding, and the way these issues are resolved can have a major impact on the sustainability of peace in a country. It is therefore timely that the Peacebuilding Commission both examines how the obstacles that returnees face can be overcome and consolidates some lessons learned about the challenges and success stories associated with the return of IDPs.

This session of the PBC Working Group on Lessons Learned will examine the comparative experience of helping IDPs to return successfully in the following five areas:

- 1. Voluntary return without coercion
- 2. Ensuring safety and security of returnees
- 3. Housing, land, and property issues in the context of displacement

- 4. Creating an environment that sustains return
- 5. Financing reintegration efforts

It is hoped that such a dialogue within the PBC will further the linkages between peacebuilding and the critical humanitarian issue of internal displacement.
