## Strategic Action Plan on youth and peacebuilding

In follow up to the PBC's regular engagement on youth, peace and security, a number of Member States have proposed, for PBC Ambassadors' consideration, the development of a Strategic Action **Plan** to help guide and monitor the Commission's efforts in support of the critical role of young women and men in peacebuilding. At the PBC ambassadorial-level meeting on youth, peace and security on 11 February 2020, the Commission committed to doing more to mainstream youth considerations into its work, in line with the twin resolutions 1 as well as SC resolutions 2250 (2015), 2419 (2018) and 2535 (2020), as well as by considering the recommendations of the Independent Progress Study on youth, peace and security "The Missing Peace". The Plan, presented below, may serve as a checklist to contribute to consistent, coherent, follow-up by the Commission, taking also into consideration SC resolution 2325 (2020) which welcomed the PBC's increased engagement in support of youth and encouraged the Commission to continue to support the important peacebuilding role that young people play and to bring its observations and advice to the attention of the Security Council, as appropriate.
