### Provisional Workplan 2018

The following provisional workplan was prepared pursuant to paragraph 4.I of the "Working methods of the Peacebuilding Commission" (as contained in the annex of the Annual report of the PBC on its eleventh session) and it will be further developed and circulated to Member States on a quarterly and monthly basis.
