Following my letter dated 11 June 2021, I have the honour to inform you that the silence procedure has been broken on revised draft resolutions on “Review process of the implementation of General Assembly resolution 67/290 and 70/299 on the follow-up and review of the 2030 Agenda for Sustainable Development at the global level and resolution 72/305 on the strengthening of the Economic and Social Council”.

In this regard, I have the further honour to circulate herewith a letter dated 11 June 2021 from H. E. Mr. Alexander Marschik, Permanent Representative of Austria and H.E. Mr. Cheikh Niang, Permanent Representative of Senegal, co-facilitators for the relevant intergovernmental negotiations conveying further revised draft resolutions, which are now placed under silence procedure until 10:00 a.m., on Tuesday, 15 June 2021 (New York time).

I encourage all delegations to continue to engage constructively and extend their full support to the co-facilitators.

We are writing to you in our capacity as co-facilitators of the intergovernmental negotiations related to General Assembly resolutions 74/298 on the review of the implementation of General Assembly resolution 67/290 on the high-level political forum on sustainable development, 70/299 on the follow-up and review of the 2030 Agenda for Sustainable Development at the global level and 72/305 on the strengthening of the Economic and Social Council.

We refer to our letters of 9 and 11 June 2021 on the silence procedure on the texts of the draft resolutions entitled “Review of the implementation of General Assembly resolution 72/305 on the strengthening of the Economic and Social Council” and “Review of the implementation of General Assembly resolutions 67/290 on format and organizational aspects of the high-level political forum on sustainable development and 70/299 on the follow-up and review of the 2030 Agenda for Sustainable Development at the global level”.

We wish to inform you that, following the breaking of the silence procedure, in order to reach a consensus, we are putting the attached revised texts under a new silence procedure until Tuesday, 15 June, 10 AM.

We reiterate our call on all delegations to exercise maximum flexibility so as to reach a consensus on those important draft resolutions. Once again, we would like to express our gratitude to all of you for your active and constructive engagement throughout this process.
