The General Assembly, composed of all Member States, is the main deliberative organ of the United Nations, and has the right to discuss and make recommendations on all matters within the scope of the Charter. The General Assembly meets once a year in regular session; special and emergency sessions are called for as the need arises.

The Index to Proceedings of the General Assembly is a bibliographic guide to the proceedings and documentation of the General Assembly. This issue covers the 13th and 14th special sessions of the Assembly.

The Thirteenth special session:

Pursuant to General Assembly resolution 40/40 of 2 Dec. 1985, the 13th special session of the General Assembly was held in 1986 to consider the critical economic situation in Africa.

The Fourteenth special session:

In its 20th report (1985) to the General Assembly, the United Nations Council for Namibia, submitted a draft resolution for adoption, entitled "Special session of the General Assembly on the question of Namibia." At its 40th session, the Assembly, by resolution 40/97 (F), decided to hold a special session in 1986 to consider the question of Namibia.

THE ARRANGEMENT OF THIS INDEX

The Index to each session consists of the following sections:

Sessional Information provides a list of officers, rules of procedure and resolutions and decisions.

Checklist of Meetings lists the plenary meetings of the Assembly and those of the main committees.

Agenda lists matters considered by and brought before the General Assembly together with the agenda item headings under which they appear in the Subject Index.

Subject Index provides topical access to General Assembly documentation. It contains an alphabetical arrangement of agenda subjects followed by a list of documents submitted to the Assembly, the meetings at which the items were considered and the action taken on each item.

Index to Speeches is subdivided into three sections: speeches by incorporated names/countries, speaker and subject.

List of documents lists documents arranged by symbol along with information regarding the republication of mimeographed documents in printed Supplements to Official Records.

DOCUMENTATION OF THE GENERAL ASSEMBLY

The symbols of all documents of the General Assembly begin with A/-, followed by the session number and an indication of the type of document to which it applies. The number following indicates the number of the document issued in that specific series. For example: A/S-13/2 is the second in the series of main documents of the 13th special session.

Meeting records are numbered in a similar way. Thus the document containing the records of the 4th plenary meeting of the 14th special session bears the symbol A/S-14/PV.4.

Reaffirms the inalienable right of the Namibian people to self-determination, freedom and national independence in an untruncated territory including Walvis Bay, the Penguin Islands and all adjacent offshore islands in accordance with the Charter of the UN and General Assembly resolution 1514 (XV) of 14 Dec. 1960, as well as the subsequent relevant resolutions and decisions of the Assembly and the Security Council; demands once again that the apartheid régime of South Africa immediately and unconditionally withdraw its illegal administration, occupation army and police force from Namibia; calls upon the UN Council for Namibia to take immediate practical measures to establish its Administration in Namibia in accordance with General Assembly resolutions 2248 (S-V) of 19 May 1967 and 40/97 of 13 Dec. 1985; emphasizes once again that the only parties to the conflict in Namibia are, on the one hand, the Namibian people represented by the SWAPO, their sole and authentic representative, and, on the other, the racist régime of South Africa, which illegally occupies the Territory; reiterates its call upon the international community to extend, as a matter of urgency, all support and assistance to the front-line States in order to enable them to defend their sovereignty and territorial integrity against the repeated acts of aggression by South Africa; reaffirms that the UN plan for the independence of Namibia, contained in Security Council resolutions 385 (1976) and 435 (1978), is the only internationally accepted basis for peaceful settlement of the question of Namibia, and demands its immediate implementation without pre-condition or modification.

A/RES/S-14/1 [B] Question of Namibia.

Calls upon South Africa to desist from linking the independence of Namibia to irrelevant and extraneous issues such as the presence of Cuban troops in Angola as such linkage is incompatible with the relevant UN resolutions, particularly Security Council resolution 435 (1978); strongly rejects the policies of "constructive engagement" and "linkage", which have served to encourage the racist régime of South Africa to continue its illegal occupation of Namibia, and calls for their abandonment so that UN resolutions and decisions on the question of Namibia can be implemented; calls upon the Security Council to convene urgently to take action for the immediate and unconditional implementation of the UN plan for the independence of Namibia, endorsed by Council resolution 435 (1978) (adopted 126-0-24).
