## A. INTRODUCTION

1. On 2 April 1947, the United Kingdom requested the Acting Secretary-General to summon a special session of the General Assembly for the purpose of constituting and instructing a Special Committee to prepare for the consideration of the question of Palestine at the second regular session of the General Assembly (document A/286). In accordance with Rule 4 of the Provisional Rules of Procedure for the General Assembly (A/71/Rev.1), the Acting Secretary-General sent a telegram conveying information of this request to the other Members of the United Nations and asking for their decision (A/295). On 13 April 1947, a majority of Members having concurred in the request of the United Kingdom, the Secretary-General, in accordance with Rule 8, summoned the first special session of the General Assembly to open on 28 April 1947 (A/295, A/295/Corr.1), and communicated to the Members the Provisional agenda (A/293). The inclusion of an additional agenda item, the termination of the Mandate over Palestine and the declaration of its independence, was requested by the Governments of Egypt (A/287), Iraq (A/288), Lebanon (A/290), Saudi Arabia (A/291), and Syria (A/289), and was circulated in the Supplementary List (A/294)
