United Nations Visiting Mission to Trust Territories
in West Africa (1952)

At its 389th plenary meeting, 3 March 1952, the Council adopted the terms of reference of a Visiting Mission to the two Togolands (Resolution 424 (X)). At its 409th plenary meeting, 27 March 1952, the Council decided that the Visiting Mission to the two Togolands would also visit the two Cameroons and that it would be composed of representatives of Australia, Belgium, China and El Salvador. At its 410th plenary meeting, 31 March 1952, the Council decided that the Visiting Mission would submit its report concerning the Togoland unification problem (for consideration by the Trusteeship Council at a second part of its eleventh session) before its proceeds on its visit to the two Cameroons, and would then draft its general report.
