EXPLANATION

**ENTRY NUMBER.** Documents, meeting records and introductory notes are referred to by entry numbers in the subject-index to this Check List. The entry numbers do not appear on the documents and should not be used in citation.

**LANGUAGE OF ISSUE.** The language editions in which a document is issued are indicated as English (E), French (F), Spanish (S), Russian (R), Chinese (C), or bilingual English-French (E&F) texts.

**DOCUMENT SYMBOL AND SHORT TITLE.** The official document symbol number should be used in citing documents. In case of publications without document symbol numbers, titles should be cited together with the session number, issue number, supplement number, and volume number, whichever is included in the entry. Title entries have been standardized and shortened or expanded in order to clarify the meaning of the titles and the authorship of the document, as the entries do not always literally conform to the actual document titles. The collation shows the pagination of the English or bilingual English-French text only. The date appearing on each document below the document symbol number is usually the date of registration of the documentary text with the Bureau of Documents for publication and translation and should be the same in all language texts. The date of registration closes each entry. Corrigenda, addenda and revisions are usually grouped with the parent document in the same entry unless a separate reference from the subject-index is called for. Corrigenda are corrections of errors in the texts, tables, dates or classifications of documents, emendations of translations, and additions of omitted text. Addenda include supplementary material, such as annexes, appendices, tables, charts and additional communications, clauses and paragraphs. Revisions are texts revised through formal amendments or new editions of a document prepared by the submitting delegation or body or by the Secretariat.

**REPUBLICATION NOTES** indicate the republication of whole documents in other documents or in the Official Records. In the case of resolutions, only their republication in collected sets is indicated.

#### 4: TRUSTEESHIP COUNCIL

RESTRICTED AND LIMITED SERIES. Documents of "restricted distribution" are indicated in this Check List by a black dot (●) before the symbol. Prior to the 15th of September 1949, this category included both documents of a confidential nature and documents the circulation of which was limited for other reasons. Since 15 September 1949\* the term "restricted series" is to be used exclusively for confidential documents. The term "limited series" is to be used for documents the wide circulation of which is unnecessary for any other reason, such as their provisional or ephemeral character. The "limited series" is not withheld from the press. In this Check List documents of "limited" distribution are indicated by a plus sign (+) before the symbol.

INTRODUCTORY NOTES give a short parliamentary history of the Council and describe briefly each Ad hoc Committee and Visiting Mission, session by session, including the date of its appointment, citing its terms of reference, naming its members and officers, listing its reports and document series symbol (if any), and tabulating its meeting records. The plenary meetings of the Council itself are shown in tables for each session. The tables indicate both published and unpublished meeting records and related press releases. Since drafts for the published meeting records should be deposited as a matter of course in the Archives of the United Nations, the tables show under the heading "Archives" only the unpublished manuscript records deposited in the Archives ("TPV"; "TSR") and the sound recordings ("X").

Establishment of the Trusteeship Council

1 The Trusteeship Council, one of the six principal organs of the United Nations, is established by Article 86 of the Charter of the United Nations. The Council consists of the following Members of the United Nations: (a) those Members administering Trust Territories; (b) such of those Members mentioned by name in Article 23 of the Charter of the United Nations as are not administering Trust Territories; and (c) as many other Members elected for three-year terms by the General Assembly as may be necessary to ensure that the total number of members of the Trusteeship Council is equally divided between those Members of the United Nations which administer Trust Territories and those which do not.

After the approval of the first Trusteeship Agreements by the General Assembly at its 62nd plenary meeting, 13 December 1946, the conditions necessary for the constitution of the Trusteeship Council could be fulfilled. Thus, in accordance with Article 86a of the Charter, Australia, Belgium, France, New Zealand and the United Kingdom became members of the Council. By Application of Article 86b, China, the Union of Soviet Socialist Republics and the United States of America also became members of the Council. In compliance with Article 86c, the General Assembly periodically elects non-administering members for a term of three years.

As a result of the entry into force of the Trusteeship Agreement for the Pacific Islands on 18 July 1947 (Document S/318), the United States of America was entrusted with the administration of a Trust Territory, and, in order therefore to ensure that a total number of members of the Council was equally divided between those Members of the United Nations which administer Trust Territories and those which do not, the General Assembly, at its 109th plenary meeting, 13 November 1947, elected two other non-administering members, thus increasing their number to four.

3 Officers of the Council, 1949

At the beginning of its regular session in June of every year the Trusteeship Council elects from among the representatives of its members a President and a Vice-President who hold office until their successors are elected.

During the fourth session of the Council, the officers who had been elected at the 2nd meeting of the third session, 16 June 1948, were: President: Mr. Liu Chieh (China); Vice-President: Sir Alan Barns (United Kingdom). Mr. Victor Hoo, Assistant Secretary-General, presided over the first two plenary meetings.

During the fifth session the following officers were elected at the second meeting, 20 June 1949: President: Mr. Roger Garreau (France); Vice-President: Mr. Luis Padilla Nervo (Mexico). Mr. Victor Hoo, Assistant Secretary-General, presided over the first plenary session. Mr. Garreau also was President during the first and second special sessions of the Council.

4 Secretary to the Council, 1949

Mr. Bozidar Aleksander (Secretariat) was Secretary to the Council during the fourth and fifth sessions and first and second special sessions. Mr. A. A. Wieschhoff acted as Secretary at several meetings of the fourth session.

5 Rules of Procedure

The rules of procedure of the Trusteeship Council, as approved at the 22nd meeting of its first session, 23 April 1947 and amended during its second session (documents T/1/Rev.1 and T/154, Check List, Part 4: No. 1, entries 3 and 227) were amended during the fourth session (3rd meeting, 26 January 1949) and fifth session (2nd meeting, 16 June 1949). See documents T/331 and T/412, entries 181, 292. They were republished as document T/1/Rev.2 (entry 178).
