INTRODUCTION

The Trusteeship Council is assigned under the Charter of the United Nations to supervise the administration of Trust Territories which are placed under the International Trusteeship System. The Council meets annually and holds special sessions when required.

The <u>Index to Proceedings of the Trusteeship</u>
<u>Council</u> is a guide to the documentation and
proceedings of the Trusteeship Council. This
issue covers the twentieth special session as
well as the fifty-seventh regular session.

The twentieth special session of the Trusteeship Council was held at the request of the United States, in order to consider the dispatch of a visiting mission to observe a plebiscite in Palau, Trust Territory of the Pacific Islands.
